6 **ORDINANCE NO. 3992**

8 An ordinance amending the Code of Ordinances of the City of Slidell, Chapter
9 23 (Solid Waste), Section 23-2 (Collection fee), Subsection (a), relative to collection fees,
10 and Subsection (b), relative to adjustments for collection fees.

11 WHEREAS, the City of Slidell wishes to return to twice per week residential
12 waste collection with once per week recycling collection for residential units within the City,
13 effective July 1, 2020; and

14
15 WHEREAS, such a reversion requires a change in the net fee structure set
16 forth in the Code of Ordinances; and

17
18 WHEREAS, the City of Slidell further desires to amend the fee adjustment
19 provision for its collection fees to conform to its negotiated contract for waste and recycling
20 collection.

23 NOW THEREFORE, BE IT ORDAINED by the Slidell City Council as follows:

25 1. Subsection (a) of Section 23-2 of Chapter 23 of the Code of Ordinances of the City
26 of Slidell is hereby amended to read as follows:

28 (a) Beginning July 1, 2020, each residential unit within the city shall be charged the
29 sum of \$12.26 per month for garbage collections and for the collection of
30 recyclable materials.

32 2. Subsection (b) of Section 23-2 of Chapter 23 of the Code of Ordinances of the City
33 of Slidell is hereby amended to read as follows:

35 (b) Beginning July 1, 2022 and every fiscal year thereafter, the fee specified herein
36 may be adjusted up by a percentage amount equal to the percentage change in
37 the Consumer Price Index, All Urban Consumers ("CPI"), published by the
38 Department of Labor, Bureau of Labor Statistics for the previous calendar year
39 or five (5%) percent, whichever is less.


