10 WHEREAS, the City of Slidell, with assistance from the Department of
11 Transportation and Development (DOTD) and the Federal Highway Administration
12 (FHWA) proposed to have Richard C. Lambert Consultants, LLC hereinafter "Consultant"
13 provide construction contract administration and construction inspection services on North
14 Shore Boulevard; and

18 WHEREAS, the City of Slidell, under authorization granted by Title 48 of
19 Louisiana Revised Statutes, has elected to engage the Consultant for the purpose of
20 expediting the inspection services; and the Consultant agrees to perform the services
21 described and for the conditions and compensation stated in the attached contract; and

24 WHEREAS, the stated project has been approved by the Louisiana
25 Legislature and the LA DOTD is agreeable to the implementation of this project and
26 desires to cooperate with the City of Slidell according to the terms and conditions identified
27 in the attached Agreement; and

30 WHEREAS, the LA DOTD will provide up to 80% of the necessary funding,
31 and the City of Slidell will provide 20% of the necessary funding.


34 NOW THEREFORE BE IT RESOLVED by the Slidell City Council that it does




