7 A resolution indicating the intention of the City of Slidell, State of Louisiana, to
8 become a participating political subdivision in the Louisiana Local Government
9 Environmental Facilities and Community Development Authority (the "Authority");
10 approving the appointment of a director to represent the City of Slidell on the Board of
11 Directors of the Authority; and otherwise providing with respect thereto as provided by
12 Chapter 10-D of Title 33 of the Louisiana Revised Statutes of 1950, as amended.

13 WHEREAS, Chapter 10-D of Title 33 of the Louisiana Revised Statutes of
14 1950, as amended, comprised of R.S. 33:4548.1 through 4548.16 is known as the
15 Louisiana Local Government Environmental Facilities and Community Development
16 Authority Act (the "Act"); and

17
18 WHEREAS, the Act creates the Louisiana Local Government Environmental
19 Facilities and Community Development Authority (the "Authority") for the purpose of
20 assisting political subdivisions, as defined in the Act, and other designated entities in
21 acquiring, financing and constructing certain facilities, including environmental, public
22 infrastructure, community and economic development purposes and to otherwise establish
23 programs to aid in the financing of local government and economic development projects;
24 and

26 WHEREAS, the City of Slidell, State of Louisiana, is eligible to become a
27 participating political subdivision of the Authority in accordance with the Act; and

29 WHEREAS, pursuant to Section 4548.4 of the Act, the governing authority of
30 City of Slidell, State of Louisiana, desires to become a member of the Authority ("Member")

6 and ratify any action taken heretofore by and on behalf of the member.


7 NOW THEREFORE BE IT RESOLVED by the governing authority of the City

9 of Slidell, State of Louisiana, acting in such capacity;

10 Section 1. Under the authority of Section 4548.4 of the Act, it is hereby

12 declared to be the express intention of the City of Slidell, State of Louisiana, to become a
13
14 participating political subdivision and member of the Authority.

15 Section 2. Pursuant to the Act, the appointment of Reinhard Dearing to serve
16
17 as a Director of the Authority for a term of two (2) years from the date hereof is hereby
18
19 approved.

20 Section 3. This resolution shall take effect immediately and a certified copy
21
22 hereof shall be forwarded to the offices of the Authority.
