6 A resolution ordering a special election to be held in the City of Slidell, St.
7 Tammany Parish, Louisiana, for the purpose of electing a new City Council Member-at-
8 Large to fill the vacancy and unexpired term created by the death of Council Member Pearl
9 Williams.

10 WHEREAS, the City of Slidell by resolution passed this day recognizes that a
11 vacancy exists in the Slidell City Council, City of Slidell, St. Tammany Parish, Louisiana;

15 WHEREAS, the governing authority for the City of Slidell is given the
16 authority and responsibility under the provisions of Louisiana Revised Statutes 18:602 and
17 Slidell Home Rule Charter Section 2-03, Paragraph C, to fill the vacancy and the position
18 of City Council Member by special election when an unexpired term exceeds one (1) year;

23 WHEREAS, the said vacancy results in an unexpired term in excess of one
24 (1) year.

26 NOW THEREFORE BE IT RESOLVED by the Slidell City Council that it does

28 hereby authorize and call a special election to be held in the City of Slidell, St. Tammany
29 Parish, Louisiana, for the purpose of electing a City Council Member-at-Large to fill the
30 vacancy effective May 17, 2007, for the unexpired term of Council Member-at-Large Pearl
31 Williams.

34 BE IT FURTHER RESOLVED that the qualifying period for said election shall

36 be from September 4 through September 6, 2007, inclusive, and that the primary election
37 shall be held on October 20, 2007, with a general election, if necessary, held on November

10 Louisiana Secretary of State, State of Louisiana, and shall further cause this resolution to
