23 Revolving Fund loan program; and







Re: State Revolving Loan Fund Pre-Application

Attached please find resolutions for four pre-applications requesting LaDEQ State Revolving Loan Fund/ Stimulus Package grant money. These resolutions are required before the Mayor can sign the preapplications. This funding is earmarked for wastewater projects which will be ready for construction within approximately 120 days. The four projects being submitted are:

1. Repair/ replacement of sewer lines to reduce infiltration & inflow. This is a continuation of our ongoing effort to fix our aging sewer collection system. Prior to Katrina, we had yearly I/I projects.
2. Rehabilitation of five sewer pump stations from the previously designed FY07 sewer pump station rehab project. There were eight stations in that design; however, only three of those have funding for construction.
3. Rehabilitation of three sewer pump stations from the previously designed FY09 sewer pump station rehab project. There were five stations in that design; however, only two of those have funding for construction.
4. Upgrade of two sewer pump stations in the mall area – the pump station by Burger King and the big station southeast of Northshore mall. Currently, there are occasional sewer overflows and backups due to the high degree of development served by these stations since they were designed. Therefore, upgrading these stations is critical.

My intent is to include these resolutions on the March 10, 2009 council agenda, to expedite submission of all four preapplications to LaDEQ. Once DEQ receives the preapplications, they prioritize the projects submitted, then notify us of our priority rating and potential funding opportunity. The pre-application does not obligate the City to accept these funds.
