6 A resolution providing for canvassing the returns and declaring the result of
7 the special election held in the City of Slidell, State of Louisiana, on Saturday, October 17,
8 2009, to authorize not to exceed \$10,000,000 of not more than 20 year general obligation
9 bonds of the City of Slidell for the purpose of acquiring, constructing and improving
10 drainage, streets and bridges, said bonds to be payable from ad valorem taxes and
11 providing for other matters in connection therewith.

12 NOW THEREFORE BE IT RESOLVED by the Slidell City Council of the City
13 of Slidell (the "City Council"), as governing authority for the City of Slidell, State of
14 Louisiana (the "City"), as follows:

15
16 SECTION 1. That the City Council does now proceed in open and public session to
17 examine the official certified tabulations of votes cast at the special election held in the City
18 on October 17, 2009 (the "Election"), to authorize the incurrence of debt and issuance of
19 general obligation bonds payable from ad valorem taxes therein, said tabulations having
20 been prepared and certified by the election officials serving at the designated polling
21 places, and the City Council does now further proceed to examine and canvass the returns
22 and declare the result of the Election.

24 SECTION 2. That a Proces Verbal of the canvass of the returns of the Election shall
25 be made and that a certified copy thereof shall be forwarded to the Secretary of State,
26 Baton Rouge, Louisiana, who shall record the same in his office; that another certified
27 copy thereof shall be forwarded to the Clerk of Court and *ex officio* Recorder of Mortgages
28 in and for the Parish of St. Tammany, State of Louisiana, who shall record the same in the
29 Mortgage Records of St. Tammany Parish; and that another copy thereof shall be retained
30 in the archives of the City.

7 SECTION 4. This Resolution shall take effect immediately upon adoption.



6 PROCES VERBAL OF THE CANVASS OF THE VOTES CAST AT THE ELECTION HELD
7 IN THE CITY OF SLIDELL, STATE OF LOUISIANA ON SATURDAY, OCTOBER 17,
8 2009.

9 BE IT KNOWN AND REMEMBERED that on the 10th day of November,
10 2009, at 6:30 p.m., at the Slidell City Council Chambers located at 1330 Bayou Lane, Suite
11 110, Slidell, Louisiana, the Slidell City Council, as governing authority for the City of Slidell,
12 State of Louisiana (the "City"), and being the authority ordering the election held therein on
13 Saturday, October 17, 2009, did examine and canvass the returns of the election, there
14 having been submitted at the election the following proposition, to-wit:

15 **TAX PROPOSITION**

16 **SUMMARY: TO AUTHORIZE NOT TO EXCEED \$10,000,000 OF NOT**
17 **MORE THAN 20-YEAR GENERAL OBLIGATION BONDS OF THE CITY OF**
18 **SLIDELL FOR THE PURPOSE OF ACQUIRING, CONSTRUCTING AND**
19 **IMPROVING DRAINAGE, STREETS AND BRIDGES, SAID BONDS TO BE**
20 **PAYABLE FROM AD VALOREM TAXES.**

21 Shall the City of Slidell, State of Louisiana (the "City"), incur debt and issue
22 bonds in an amount not to exceed Ten Million Dollars (\$10,000,000), in one
23 or more series, to mature on or before twenty (20) years from date thereof,
24 with interest at a rate not exceeding nine percent (9%) per annum, for the
25 purpose of acquiring, constructing and improving drainage, streets and
26 bridges; which bonds will be general obligations of the City and will be
27 payable from ad valorem taxes to be levied and collected in the manner
28 provided by Article VI, Section 33 of the Constitution of the State of Louisiana
of 1974 and statutory authority supplemental thereto?

29 There was found by said count and canvass that the following votes had
30 been cast at the said special election IN FAVOR OF and AGAINST, respectively, the
31 proposition as hereinabove set forth at the following polling places, to-wit:

24 as hereinabove set forth, and that there was a majority of 439 votes cast FOR the
25 Proposition as hereinabove set forth.


29 THEREFORE, the Slidell City Council does hereby declare and proclaim in
30 open and public session that the Proposition, as hereinabove set forth, was duly CARRIED
31 by a majority of the votes cast by the qualified electors voting at the election held in the
32 City on Saturday, October 17, 2009, and that the result of said election be promulgated by
33 the Secretary of State and by the Clerk of the Slidell City Council in the manner required
34 by law.
