9 NOW THEREFORE BE IT RESOLVED by the Slidell City Council (the
10 "Governing Authority"), acting as the governing authority of the City of Slidell, State of
11 Louisiana (the "City"), as follows:

14 SECTION 1. That the Governing Authority does now proceed in open and public
15 session to examine the official certified tabulations of votes cast at the special election held
16 in the City on March 27, 2010 (the "Election"), said tabulations having been prepared and
17 certified by the election officials serving at the designated polling places, and the
18 Governing Authority does now further proceed to examine and canvass the returns and
19 declare the result of the Election.

24 SECTION 2. That a Proces Verbal of the canvass of the returns of the Election
25 shall be made and that a certified copy thereof shall be forwarded to the Secretary of
26 State, Baton Rouge, Louisiana, who shall record the same in his office; that another
27 certified copy thereof shall be forwarded to the Clerk of Court and ex-officio Recorder of
28 Mortgages in and for the Parish of St. Tammany, State of Louisiana, who shall record the
29 same in the Mortgage Records of St. Tammany Parish; and that another copy thereof shall
30 be retained in the archives of the Governing Authority.

PROCES VERBAL OF THE CANVASS OF THE VOTES CAST AT THE ELECTION HELD IN THE CITY OF SLIDELL, STATE OF LOUISIANA ON SATURDAY, MARCH 27, 2010.

BE IT KNOWN AND REMEMBERED that on the 27th day of April, 2010 at 6:30 p.m., at the Slidell City Council Chambers, 1330 Bayou Lane, Slidell, Louisiana, the Slidell City Council, as governing authority for the City of Slidell, State of Louisiana (the "City"), and being the authority ordering the election held therein on Saturday, March 27, 2010, did examine and canvass the returns of the election, there having been submitted at the election the following propositions, to-wit:

Proposition No. 1

Summary: Provides for the deletion of the following obsolete sections.

Shall the following Section 2-02(A) of the Slidell Home Rule Charter be deleted? "A. In the event of annexation by the governing body of the City of Slidell between the time of adoption of this charter and thirty (30) days before the election of the first city council, provided for herein, the charter commission shall immediately alter, change or rearrange council district lines in order to incorporate into such districts those persons living in the newly annexed areas." AND Shall the following Section 2-02(B) of the Slidell Home Rule Charter be deleted? "B. Following the election of the first council under this charter, any ordinance annexing new areas to the City shall prescribe the council district or districts in which said area shall be included."

Proposition No. 2

Summary: Provides for the deletion of the following obsolete sections.

Shall the following Section 8-11 of the Slidell Home Rule Charter be deleted? "The alternative proposition concerning selection of the chief of police approved by the voters shall become Section 4-05 of the new charter. The alternative proposition not approved shall be null, void and of no effect and shall be deemed stricken from the proposed charter." AND Shall the following Section 8-12 of the Slidell Home Rule Charter be deleted?

13 **Shall the following Section 2-04(A) of the Slidell Home Rule Charter be**
14 **deleted? "A council member shall be paid compensation of five**
15 **hundred fifty dollars (\$550.00) per month, until charged [changed] by**
16 **ordinance. No ordinance changing the compensation of a council**
17 **member shall be adopted during the last year of a term of office and no**
18 **such ordinance shall become effective during the term of the council**
19 **adopting the ordinance." And reenacted to read as follows? "Council**
20 **members' salary shall be established annually by ordinance through**
21 **the budget process. No ordinance changing the salary shall increase**
22 **the salary by more than the average percentage of increase granted**
23 **annually to all city employees."**

27 **Summary: Provides for annual establishment of the Mayor's**
28 **compensation through the budget process.**

29 **Shall the following Section 3-06 Compensation of the Slidell Home Rule**
30 **Charter be deleted? "The annual salary of the mayor shall be no less**
31 **than twenty-eight thousand three hundred fifty dollars (\$28,350.00).**
32 **This annual salary may be changed by ordinance. No ordinance**
33 **changing the salary shall increase the salary by more than the average**
34 **percentage of increase granted annually to all city employees." And**
35 **reenacted to read as follows? "The Mayor's salary shall be established**
36 **annually by ordinance through the budget process. No ordinance**
37 **changing the salary shall increase the salary by more than the average**
38 **percentage of increase granted annually to all city employees."**

Proposition No. 6

Summary: Provides for annual establishment of the Police Chief's compensation through the budget process.

Shall the following Section 4-05(D) of the Slidell Home Rule Charter be deleted? "The annual salary of the Police Chief shall be no less than twenty-two thousand six hundred eighty dollars (\$22,680.00). This annual salary may be changed by ordinance. No ordinance changing the salary shall increase the salary by more than the average percentage of increase granted annually to all city employees." And reenacted to read as follows? "The salary of the Chief of Police shall be established annually by ordinance through the budget process. No ordinance changing the salary shall increase the salary by more than the average percentage of increase granted annually to all city employees."

Proposition No. 8

Summary: Provides for elected officials to take office on July 1 following their election.

Shall the following Section 8-10 of the Slidell Home Rule Charter be deleted? "Municipal elections for the officials provided for by this charter shall be held on the dates established by general state law applicable to the City. Persons elected under the provisions of this charter shall take office at noon on the first Monday in July next following their election." And reenacted to read as follows? "Municipal elections for the officials provided for by this charter shall be held on the dates established by general state law applicable to the City. Persons elected under the provisions of this charter shall take office on July 1 following their election."

Proposition No. 9

Summary: Provides for the deletion of the prohibition of City Council members being employed by the City within one year following the end of their term.

Shall the following Section 2-05(A) of the Slidell Home Rule Charter be deleted? "Except as otherwise provided in Sections 3-04 (Vacancies) and 3-05 (Mayor's Absence and Disability), a council member shall not hold any other elected public office, city office or city employment during the term for which elected to the council. No former council member shall hold any compensated appointive city office or city employment until one year after the expiration of the term for which elected to the council." And reenacted as follows? "Except as otherwise provided in Sections 3-04 (Vacancies) and 3-05 (Mayor's Absence and Disability), a council member shall not hold any other elected public office, city office or city employment during the term for which elected to the council."


