9  
10 Community Development Block Grant Disaster Recovery (CDBG-DR) infrastructure  
11 Program; and

13 WHEREAS, the Department of Housing & Urban Development regulations  
14 require the City of Slidell certify that the activities for which CDBG funds are being  
15 requested are designed to alleviate existing conditions which pose a serious and  
16 immediate threat to the health or welfare of the community; which are of recent origin or  
17 which recently became urgent, and that the City of Slidell is unable to finance the activity  
18 on its own, and that no other funds are available.



23 NOW THEREFORE BE IT RESOLVED by the Slidell City Council that the City  
24 of Slidell hereby certifies that the activities for which CDBG funds are being requested for  
25 the installation of emergency power equipment project are designed to alleviate existing  
26 conditions which pose a serious and immediate threat to the health and welfare of the  
27 community; are of recent origin or which recently became urgent and that the City of Slidell  
28 is unable to finance the activity on its own and there are no other funds available.
