7 WHEREAS, the Gold Award represents the highest achievement in Girl  
8 Scouts and therefore is a commitment you make and complete as an individual; and

10 WHEREAS, by earning the Girl Scout Gold Award you will be joining the  
11 ranks of generations of young women who have made a difference both locally and  
12 globally, you are in an exceptional position to take action and make the world a better  
13 place; and

15 WHEREAS, there are over 2 million Girl Scouts in the United States, but only  
16 about 4,000 receive the Gold Award each year; and

18 WHEREAS, to receive this award Ms. Lloyd had to create and implement a  
19 sustainable and ongoing community service project that demonstrated leadership and  
20 planning abilities, and promoted positive values, personal and spiritual growth, and  
21 community service; and

23 WHEREAS, a minimum of 135 hours were required for the seven steps of the  
24 Gold Award process; and

26 WHEREAS, Ms. Lloyd, a 12-year Girl Scout, is the daughter of Wendi and  
27 "Buddy" Lloyd and was a member of Slidell Troop 864. She is a 2010 Pope John Paul II  
28 High School graduate and attends Louisiana State University, majoring in elementary  
29 education. Ms. Lloyd's project was to develop a new Patch Program for Scouts by

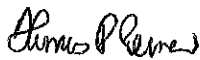
7                   NOW THEREFORE BE IT RESOLVED by the Slidell City Council that it does
