7 A resolution ordering and calling a special election to be held in the City of
8 Slidell, State of Louisiana, to authorize the rededication of a sales and use tax therein;
9 making application to the State Bond Commission in connection therewith; and providing
10 for other matters in connection therewith.

11 NOW THEREFORE BE IT RESOLVED by the Slidell City Council (the
12 "Governing Authority"), acting as the governing authority of the City of Slidell, State of
13 Louisiana (the "City"), that:
14

15 SECTION 1. Election Call. Subject to the approval of the State Bond
16 Commission, and under the authority conferred by Article VI, Section 29 of the Constitution
17 of the State of Louisiana of 1974, the applicable provisions of Chapter 5 and Chapter 6-A
18 of the Louisiana Election Code, and other constitutional and statutory authority, a special
19 election is hereby called and ordered to be held in the City on **SATURDAY, DECEMBER**
20 **8, 2012**, between the hours of six o'clock (6:00) a.m., and eight o'clock (8:00) p.m., in
21 accordance with the provisions of La. R.S. 18:541, and at the said election there shall be
22 submitted to all registered voters qualified and entitled to vote at the said election under
23 the Constitution and laws of this State and the Constitution of the United States, the
24 following proposition, to-wit:

5 **PROPOSITION**
6 **(SALES TAX REDEDICATION)**

7 Summary: Authority to rededicate the proceeds of a 1% sales and use
8 tax authorized at an election held on September 27, 1986.

9
10 Shall the City of Slidell, State of Louisiana (the "City") be authorized to
11 rededicate the proceeds received by the City from the levy and
12 collection of a 1% sales and use tax authorized at an election held on
13 September 27, 1986 (an estimated \$9,000,000 reasonably expected
14 at this time to be collected from the levy of the tax for an entire year)
15 so that such proceeds (after paying the reasonable and necessary
16 costs and expenses of collecting and administering the tax) may
17 continue to be used for those lawful public purposes set forth in the
18 proposition approved at said election of September 27, 1986, and,
19 beginning July 1, 2013, for paying the operational costs of police
20 protection and public safety?

21 SECTION 2. Publication of Notice of Election. A Notice of Special Election
22 shall be published in the *St. Tammany News*, a newspaper of general circulation within
23 the City, published in Slidell, Louisiana, and being the official journal of the City, once a
24 week for four consecutive weeks, with the first publication to be made not less than
25 forty-five (45) days nor more than ninety (90) days prior to the date of the election, which
26 Notice shall be substantially in the form attached hereto as "Exhibit A" and incorporated
27 herein by reference the same as if it were set forth herein in full.

31 SECTION 3. Canvass. This Governing Authority shall meet at its regular
32 meeting place, the 2045 Second Street, Council Chambers, Slidell, Louisiana, on
33 **TUESDAY, JANUARY 8, 2013, at SIX-THIRTY O'CLOCK (6:30) P.M.**, and shall then and
34 there in open and public session proceed to examine and canvass the returns and declare
35 the result of the said special election.

4 SECTION 4. Polling Places. The polling places set forth in the aforesaid
5 Notice of Special Election are hereby designated as the polling places at which to hold the
6 said election, and the Commissioners-in-Charge and Commissioners, respectively, will be
7 the same persons as those designated in accordance with law.
8

10 SECTION 5. Election Commissioners; Voting Machines. The officers
11 designated to serve as Commissioners-in-Charge and Commissioners pursuant to Section
12 4 hereof, or such substitutes therefor as may be selected and designated in accordance
13 with La. R.S. 18:1287, shall hold the said special election as herein provided, and shall
14 make due returns of said election for the meeting of the Governing Authority to be held on
15 Tuesday, January 8, 2013, as provided in Section 3 hereof. All registered voters in the
16 City will be entitled to vote at the special election, and voting machines shall be used.
17
18

19 SECTION 6. Authorization of Officers. The Council Administrator of the
20 Governing Authority is hereby empowered, authorized and directed to arrange for and to
21 furnish to said election officers in ample time for the holding of said election, the necessary
22 equipment, forms and other paraphernalia essential to the proper holding of said election
23 and the Mayor and/or Council Administrator of the Governing Authority are further
24 authorized, empowered and directed to take any and all further action required by State
25 and/or Federal law to arrange for the election, including but not limited to, appropriate
26 submission to the Federal Department of Justice under Section 5 of the Federal Voting
27 Rights Act of 1965, as amended.

30 SECTION 7. Furnishing Election Call to Election Officials. Certified copies of
31 this resolution shall be forwarded to the Secretary of State, the Clerk of Court and

4 *Ex-Officio* Parish Custodian of Voting Machines of St. Tammany Parish and the Registrar
5 of Voters of St. Tammany Parish, as notification of the special election, in order that each
6 may prepare for said election and perform their respective functions as required by law.

9 SECTION 8. Application to State Bond Commission. Application is made to
10 the State Bond Commission for consent and authority to hold the special election as herein
11 provided, and in the event said election carries for further consent and authority to
12 rededicate the sales and use tax provided for therein. A certified copy of this resolution
13 shall be forwarded to the State Bond Commission on behalf of this Governing Authority,
14 together with a letter requesting the prompt consideration and approval of this application.




