9 Airport Improvement Program as approved by the FAA and the Louisiana Department of
10 Transportation and Development (LA DOTD) Aviation Division.

11 WHEREAS, the City of Slidell owns, operates and maintains the Slidell
12 Municipal Airport; and

14 WHEREAS, the City has submitted an application to the Federal Aviation
15 Administration (FAA) to provide Airport Improvement Program (AIP) grant funding for
16 TAXIWAY "A" MIDDLE SECTION AND NORTH APRON PAVEMENT REHABILITATION;

21 WHEREAS, the proposed project cost of \$422,152.00 shall be funded by 90%
22 Federal and 10% LADOTD State grant funds under the Airport Improvement Program.

24 NOW THEREFORE BE IT RESOLVED BY THE SLIDELL CITY COUNCIL,
25 that the grant offer be accepted and that the Mayor shall have the authority to execute all
26 Federal and State grant agreements required for TAXIWAY "A" MIDDLE SECTION AND
27 NORTH APRON PAVEMENT REHABILITATION as approved by the FAA and the LA
28 DOTD Aviation Division.


