10 "Governing Authority"), acting as the governing authority of the City of Slidell, State of
11 Louisiana (the "City"), that:

13 SECTION 1. Canvass. This Governing Authority does now proceed in open
14 and public session to examine the official tabulations of votes cast at the special election
15 held in the City of Slidell, State of Louisiana , (the "City"), on SATURDAY, DECEMBER 8,
16 2012, to authorize the rededication of a sales and use tax therein, and said Governing
17 Authority does further proceed to examine and canvass the returns and declare the result
18 of the special election.

24 SECTION 2. Procès Verbal. A *Procès Verbal* of the canvass of the returns
25 of said election shall be made and a certified copy thereof shall be forwarded to the
26 Secretary of State, Baton Rouge, Louisiana, who shall record the same in his office;
27 another certified copy thereof shall be forwarded to the Clerk of Court and *Ex-Officio*
28 Recorder of Mortgages in and for the Parish of St. Tammany, who shall record the same in
29 the Mortgage Records of said Parish; and another copy thereof shall be retained in the
30 archives of this Governing Authority.

31 Summary: Authority to rededicate the proceeds of a 1% sales and use tax
32 authorized at an election held on September 27, 1986.

33 Shall the City of Slidell, State of Louisiana (the "City") be authorized to
34 rededicate the proceeds received by the City from the levy and collection of a
35 1% sales and use tax authorized at an election held on September 27, 1986
36 (an estimated \$9,000,000 reasonably expected at this time to be collected
37 from the levy of the tax for an entire year) so that such proceeds (after paying
38 the reasonable and necessary costs and expenses of collecting and
39 administering the tax) may continue to be used for those lawful public
purposes set forth in the proposition approved at said election of September

4 27, 1986, and , beginning July 1, 2013, for paying the operational costs of
 5 police protection and public safety?
