6 A resolution requesting the City extend city water services beyond city limits  
7 to the property located at 1595 Hwy. 190 East, Slidell, Louisiana, pursuant to City of Slidell  
8 Code Of Ordinance Section 2-35, pending approval of said property being annexed into  
9 the City of Slidell.

10 WHEREAS, Marie Olroyd, is desirous of annexing her property located at  
11 1595 Hwy. 190 East, Slidell, into the corporate limits of the City of Slidell; and

12  
13 WHEREAS, Marie Olroyd intends to file a Petition for Annexation with the  
14 City; and

15  
16 WHEREAS, Marie Olroyd desires, pending the processing and approval of  
17 her Petition for Annexation, that the City extend City water services beyond the City  
18 corporate limits to her property located at 1595 Hwy. 190 East, Slidell; and

21 WHEREAS, Marie Olroyd shall be responsible for, and timely pay, all costs  
22 associated with the installation and connection of said water line in addition to all monthly  
23 usage fees; and

26 WHEREAS, City desires, subject to the foregoing, to extend City water  
27 services to said location, pending approval of Marie Olroyd's Petition for Annexation; and

29 WHEREAS, City reserves the right to immediately withdraw City water  
30 services to said location, should, for any reason whatsoever, the Petition for Annexation  
31 not be approved within eight (8) months of filing of same.

34 NOW THEREFORE BE IT RESOLVED by the Slidell City Council that it does  
35 hereby expressly approve the extension of City water services to the property owned by  
36 Marie Olroyd located at 1595 Hwy. 190 East, Slidell, pursuant to City of Slidell Code of
