4 **RESOLUTION R13-18**

5 A resolution approving the extension of City water and sewer services beyond
6 City limits to the property located at 2100 Gause Blvd. East, Slidell, Louisiana, pursuant to
7 City of Slidell Code of Ordinance, Section 2-35, conditioned upon annexation of said
8 property into the City of Slidell.

9 WHEREAS, Munir T. Mustafa is desirous of annexing property located at
10 2100 Gause Blvd. East, Slidell, Louisiana, into the corporate limits of the City of Slidell;

14 WHEREAS, Munir T. Mustafa has submitted a Petition for Annexation with the
15 City of Slidell; and

17 WHEREAS, Munir T. Mustafa desires that pending the application and
18 approval of Petition for Annexation, the City extend City water services beyond the City
19 corporate limits to property located at 2100 Gause Blvd. East, Slidell, Louisiana; and

22 WHEREAS, Munir T. Mustafa shall be responsible for and timely pay all costs
23 associated with the installation and connection of said water line in addition to all monthly
24 usage fees; and

28 services to said location, conditioned upon approval of Munir T. Mustafa's Petition for
29 Annexation; and

11 Annexation not be approved within one (1) year of filing of same.


14 NOW THEREFORE BE IT RESOLVED by the Slidell City Council that it does
15 hereby expressly approve the extension of City water and sewer services to the property
16 owned by Munir T. Mustafa, 2100 Gause Blvd. East, Slidell, Louisiana, pursuant to
17 Ordinance, Section 2-35, conditioned upon annexation.

20 BE IT FURTHER RESOLVED that the City reserves the right to immediately
21 withdraw City water and sewer services to the property owned by Munir T. Mustafa located
22 at 2100 Gause Blvd. East, Slidell, Louisiana, should the Petition for Annexation be
23 withdrawn for any reason or should Petitioner fail to participate, in a timely fashion, in
24 accordance with the annexation process.
