9 (10) year, three (3) mill property tax for maintenance and operation of the municipal police  
10 department of the City; (ii) a ten (10) year, five (5) mill property tax for maintaining and  
11 operating sewerage works and facilities within and for the City; and (iii) a ten (10) year, five  
12 (5) mill property tax for constructing and maintaining garbage disposal work and refuse  
13 and garbage collection and disposal systems within and for the City; and providing for  
14 other matters in connection therewith.

15 NOW THEREFORE BE IT RESOLVED by the Slidell City Council (the  
16 "Governing Authority"), acting as the governing authority of the City of Slidell, State of  
17 Louisiana (the "City"), that:

19 SECTION 1. That the Governing Authority does now proceed in open  
20 and public session to examine the official certified tabulations of votes cast at the special  
21 election held in the City on October 19, 2013 (the "Election"), said tabulations having been  
22 prepared and certified by the election officials serving at the designated polling places, and  
23 the Governing Authority does now further proceed to examine and canvass the returns and  
24 declare the result of the Election.

26 SECTION 2. That a Proces Verbal of the canvass of the returns of the  
27 Election shall be made and that a certified copy thereof shall be forwarded to the Secretary  
28 of State, Baton Rouge, Louisiana, who shall record the same in his office; that another  
29 certified copy thereof shall be forwarded to the Clerk of Court and ex-officio Recorder of  
30 Mortgages in and for the Parish of St. Tammany, State of Louisiana, who shall record the


7 SECTION 3. That the result of the Election shall be promulgated by

THEREFORE, the City Council of the City of Slidell, State of Louisiana (the "Governing Authority"), acting as the governing authority of the City of Slidell, State of Louisiana (the "City"), does hereby declare and proclaim in open and public session that each of the Propositions, as hereinabove set forth, were duly PASSED in the City on Saturday, October 19, 2013, and that the results of said election be promulgated by the Secretary of State and by the Clerk of Court in the manner required by law.


