
5 A resolution extending the moratorium relating to off-street parking.

10 WHEREAS, the Slidell City Council adopted Ordinance 3615 on May 24,
11 2011 which amended Appendix A, Zoning, Part 4, Section 4.104 to the Code of
12 Ordinances relative to off-street parking in all residential zoning districts; and

15 WHEREAS, issues relating to the enforcement of Section 4.104 have arisen;

18 WHEREAS, the City believes that further study is required in order to
19 promulgate an ordinance that more clearly sets forth the intent of the Council.

21 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that a
22 moratorium on the enforcement of Appendix A, Zoning, Part 4, Section 4.104 is hereby
23 imposed until February 28, 2015 or until another date shall be specified by the Council.
