WHEREAS, City reserves the right to immediately withdraw City water and sewer services to said location, should for any reason whatsoever, the Petition for Annexation not be approved within one (1) year of filing of same.

NOW THEREFORE BE IT RESOLVED by the Slidell City Council that it does hereby expressly approve the extension of City water and sewer services to the property owned by Man of Steel, Inc., 249 Stone Road, Slidell, Louisiana, pursuant to Ordinance, Section 2-35, conditioned upon annexation.

BE IT FURTHER RESOLVED that the City reserves the right to immediately withdraw City utilities to the property owned by Man of Steel, Inc. located at 249 Stone Road, Slidell, Louisiana, should the Petition for Annexation be withdrawn for any reason or should Petitioner fail to participate, in a timely fashion, in accordance with the annexation process.

BE IT FINALLY RESOLVED that the City reserves the right to immediately withdraw City water Services to the property owned by Man of Steel, Inc. located at 249 Stone Road, Slidell, Louisiana, should, for any reason whatsoever, the Petition for Annexation not be approved within one (1) year of filing of same.
