28 funding through the Drinking Water Revolving Loan Fund Program.

30 such additional information as may reasonably be required in connection with the Loan
31 Application.

32 SECTION 3. That Blaine Clancy, City Engineer, is hereby designated as the
33 Office Project Representative and is hereby given signature authority for all relative
34 documents for Slidell for any project that may result from the submission of the Loan
35 Application Form 100A and accompanying documents. Furthermore, Blaine Clancy, City
36 Engineer, representing the City of Slidell is hereby given the power and authority to do all
37 things necessary to implement, maintain, amend, and renew such documents relative to
38 any such project.
