WHEREAS, City reserves the right to immediately withdraw City water and sewer services to said location, should, for any reason whatsoever, the Petition for Annexation not be approved within six (6) months of filing of same.

NOW THEREFORE BE IT RESOLVED by the Slidell City Council that it does hereby expressly approve the extension of City water and sewer services to the property owned by Clade Enterprises, LLC, owner of 1189 Fremaux Avenue, Slidell, Louisiana, pursuant to Ordinance, Section 2-35, conditioned upon annexation of Clade property located at 1189 Fremaux Avenue, Slidell, Louisiana.

BE IT FURTHER RESOLVED that the City reserves the right to immediately withdraw City water and sewer services to the property owned by Clade located at 1189 Fremaux Avenue, Slidell, should the Petition for Annexation be withdrawn for any reason or should Clade fail to participate, in a timely fashion, in accordance with the annexation process.

BE IT FINALLY RESOLVED that the City reserves the right to immediately withdraw City water Services to the property owned by Clade located at 1189 Fremaux Avenue, Slidell, Louisiana, should, for any reason whatsoever, the Petition for Annexation not be approved within six (6) months of filing of same.
