4 **RESOLUTION R21-06**

6 A resolution authorizing the extension of water and sewer utility services
7 beyond the City limits to the property at 1729 Gause Boulevard East and rescinding
8 resolution R21-05.

9 WHEREAS, on March 9, 2021, the Slidell City Council adopted resolution R21-
10 05; and

11
12 WHEREAS, as a result of a drafting error, the property which was the intended
13 subject of that resolution was incorrectly designated; and

14
15 WHEREAS, the property located at 1729 Gause Boulevard East is the correctly
16 designated property (sometimes "Property") and is located outside the City limits but is
17 adjacent to property within the City limits; and

18
19 WHEREAS, the owner of the Property has requested that City water and
20 sewer utility services be extended to the Property; and

21
22 WHEREAS, Chapter 2, Article II, Division I, Section 2-35 of the Code of
23 Ordinances of the City of Slidell states that the City shall not grant the extension of any
24 City services, including utilities, to any property located outside the corporate limits of the
25 City without the express approval of the City Council, in legal session convened; and

27 WHEREAS, the Council has no objection to the Property owner's request for
28 City water and sewer utility services, subject to the Property owner's payment of all costs
29 associated with the service extensions and the applicable monthly rates and other charges
30 associated with those services; and

4 WHEREAS, in conjunction with the adoption of this resolution, the Council

6 wishes to rescind resolution R21-05 which contained the drafting error.

7 NOW THEREFORE, BE IT RESOLVED by the Slidell City Council that the

9 extension of City water and sewer utility services to the property located at 1729 Gause
10
11 Boulevard East is hereby approved, subject to the payment by the Property owner of all
12
13 costs associated with the service extensions as well as the monthly rates and other
14
15 charges specified by the Code of Ordinances of the City of Slidell for water and sewer
16
17 users outside the corporate limits. Any such extension of City water and sewer utility
18
19 services to 1729 Gause Boulevard East which occurred subsequent to March 9, 2021 and
20
21 prior to the adoption of this resolution is hereby ratified.

22 BE IT FURTHER RESOLVED by the Slidell City Council that resolution R21-

24 05 is hereby rescinded.
