

ORDINANCE NO. 1000

An Ordinance of the City of Slidell, Louisiana, enlarging the boundaries of the said City.

WHEREAS, the City Council of the City of Slidell, Louisiana, the governing Body of said municipality, did receive a petition from William E. Wright, Executive Secretary, Louisiana Association of Christian Churches, requesting the enlargement of the City's boundaries and

WHEREAS, the said Governing Body did investigate and did find that said petitioner is the sole owner of said property and did give notice of its intention to extend the corporate limits and zone as requested in said petition, by publication in the Slidell Daily Times, March 25th, April 1st, and 8th, 1976, and no one requested a public hearing or objected to said petition,

NOW, THEREFORE BE IT ORDAINED by the City Council of the City of Slidell, Louisiana, in legal session convened:

SECTION 1. The boundaries of the City of Slidell, Louisiana, be enlarged to include the following described property, to-wit:

Parcel A. From the corner common to Sections 35 and 36, Township 8 South, Range 14 East, and Sections 1 and 2, Township 9 South, Range 14 East, go North 415.8 feet to a point located on the North right of way line of Robert Road; thence go South 69 degrees 40 minutes West along the North right of way line of Robert Road 419.2 feet to the point of beginning. Thence continue South 69 degrees 40 minutes West along the North right of way line of Robert Road 213.29 feet to a point; thence go North 592.15 feet to a point; thence go East 200 feet to a point; thence go South 518.04 feet to the point of beginning. Said property containing 2.55 acres.

Parcel B. From the corner common to Sections 35 and 36, Township 8 South, Range 14 East, and Section 1 and 2, Township 9 South, Range 14 East, go North 415.8 feet to a point located on the North right of way line of Robert Road; thence go South 69 degrees 40 minutes West 632.49 feet to the point of beginning; thence continue South 69 degrees 40 minutes West along the North right of way line of Robert Road 319.91 feet to a point; thence go North 1,266 feet to a point; thence go East 500 feet to a point; thence go South 562.66 feet to a point; thence go West 200 feet to a point; thence go South 592.15 feet to the point of beginning. Said property containing 11.0 acres.

Containing a total of 13.55 acres.

SECTION 2. All of the property described above shall be included in, and become part of, the City of Slidell, Louisiana and be zoned A-6 and C-2.

This Ordinance having been submitted to a vote, the vote thereon was as follows:
