

ORDINANCE NO. 1006

AN ORDINANCE REVOKING DEDICATION OF A PORTION OF A STREET
OF PALM LAKE ADDITION TO SLIDELL.

BE IT ENACTED BY THE MAYOR AND CITY COUNCIL OF THE CITY
OF SLIDELL, LOUISIANA, IN LEGAL SESSION CONVENED:

THAT THE CITY OF SLIDELL APPROVED A SUBDIVISION KNOWN AS
PALM LAKE ADDITION TO SLIDELL, LOUISIANA, AND

THAT THE OWNER OF LOTS 19 AND 20, SQ. 5 OF SAID SUBDIVISION
HAS REQUESTED A REVOCATION OF A PORTION OF CAMELLIA (HYBISCUS) DRIVE,
AND

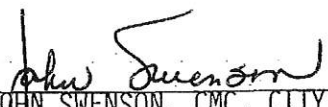
THAT THE PLANNING COMMISSION OF THE CITY OF SLIDELL HAS
APPROVED THE CHANGES, NOW THEREFORE

BE IT ORDAINED, THAT THE CITY OF SLIDELL HEREBY EXPRESSLY
REVOKES THE PREVIOUS DEDICATION OF THAT PORTION OF STREET KNOWN AS
CAMELLIA (HYBISCUS) DRIVE, ADJACENT TO LOTS 19 AND 20, SQ. 5, PALM
LAKE ADDITION TO SLIDELL HAVING A RADIUS OF 37.5 FEET, MAKING LOTS
19 AND 20 HAVING A FRONTAGE ON CAMELLIA (HYBISCUS) DRIVE OF 75.0
FEET, SIDELINES OF 90.0 FEET EACH, ALL AS MORE FULLY SHOWN ON SURVEY
NO. 5975 BY IVAN M. BORGES, C.E., DATED FEB. 27, 1976, REVISED
APRIL 30, 1976 AS OUTLINED IN RED BY NEIL ALFORD, A COPY OF WHICH

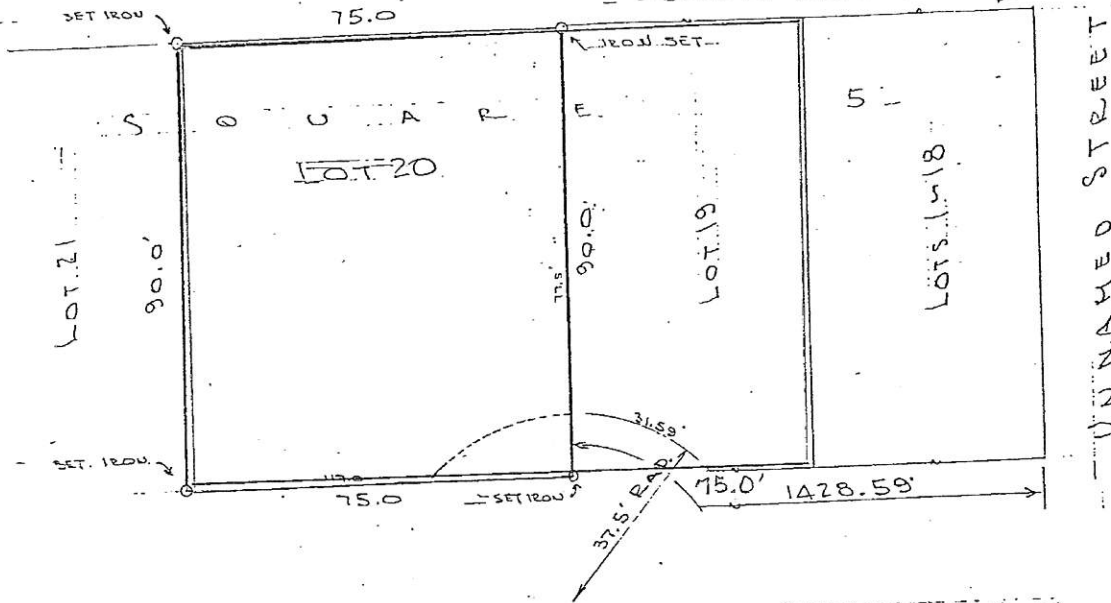

HYDRISCUS (CAMELLIA) DERTUE

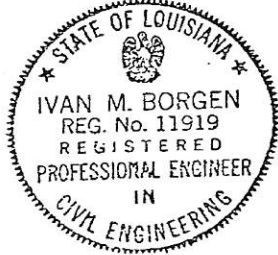
SURVEY MAP
