ORDINANCE NO. 1007

AN ORDINANCE RATIFYING HOUSE BILL 749, 1976 REGULAR SESSION DEALING WITH THE CREATION AND IMPLEMENTATION OF THE MUNICIPAL POLICE EMPLOYEES CIVIL SERVICE BOARD OF THE CITY OF SLIDELL AND APPOINTING TWO MEMBERS TO THE MUNICIPAL POLICE EMPLOYEES CIVIL SERVICE BOARD OF THE CITY OF SLIDELL FOR TERMS ACCORDING TO SAID STATUTE;

WHEREAS, IN THE REGULAR SESSION OF THE LOUISIANA LEGISLATURE OF 1976 HOUSE BILL 749 WAS PASSED AND SIGNED BY THE GOVERNOR ON JULY 2, 1976, AND;

WHEREAS, THIS ACT SETS UP A MUNICIPAL POLICE EMPLOYEES CIVIL SERVICE BOARD OF THE CITY OF SLIDELL, AND;

WHEREAS, THIS ACT PLACES EMPLOYEES OF THE SLIDELL POLICE DEPARTMENT UNDER A SYSTEM OF CIVIL SERVICE, AND;

WHEREAS, THE MAYOR AND CITY COUNCIL OF THE CITY OF SLIDELL ARE IN FAVOR OF SAID SYSTEM AS SET OUT IN HOUSE BILL 749, AND;

WHEREAS, IT IS NECESSARY TO APPOINT TWO CITIZENS OF THIS CITY TO THE MUNICIPAL POLICE EMPLOYEES CIVIL SERVICE BOARD BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SLIDELL;

BE IT ENACTED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SLIDELL, LOUISIANA, IN SPECIAL SESSION CONVENED:

THAT THE PROVISIONS OF HOUSE BILL No. 749 OF THE REGULAR SESSION OF THE LOUISIANA LEGISLATURE OF 1976 BE AND IS HEREBY RATIFIED AND PROMULGATED AS THE ORGANIC LAW OF THE CITY OF SLIDELL;

BE IT FURTHER ORDAINED THAT EDWARD SHAMIS, SR. IS HEREBY APPOINTED TO A SIX YEAR TERM AS A MEMBER OF THE MUNICIPAL POLICE EMPLOYEES CIVIL SERVICE BOARD OF THE CITY OF SLIDELL;

BE IT FURTHER ORDAINED THAT CHARLES B. RICHARDSON, JR. IS HEREBY APPOINTED TO A FIVE YEAR TERM AS A MEMBER OF THE MUNICIPAL POLICE EMPLOYEES CIVIL SERVICE BOARD OF THE CITY OF SLIDELL;

THIS ORDINANCE HAVING BEEN SUBMITTED TO A VOTE, THE VOTE THEREON WAS AS FOLLOWS:
