

ORDINANCE NO. 1043

An Ordinance of the City of Slidell, Louisiana, enlarging the boundaries of the said City.

WHEREAS, the City Council of the City of Slidell, Louisiana, the governing body of said municipality, did receive a petition from Mr. Bill Garrett, requesting the enlargement of the City's boundaries, and

WHEREAS, the said governing body did investigate and did find that said petitioner is the sole owner of said property and did give notice of its intention to extend the corporate limits as requested in said petition, by publication in the Slidell Sentry News, December 15th, 22nd and 25th, and no one requested a public hearing or objected to said petition,

NOW, THEREFORE BE IT ORDAINED by the City Council of the City of Slidell, Louisiana, in legal session convened:

SECTION 1. The boundaries of the City of Slidell, Louisiana, be enlarged to include the following described property, to-wit:

Daney Street from the present City limits to the middle of the W-14 Canal, commencing at a section corner common to Section 10, 11, 14 and 15 go East 316.84 feet to the middle of W14 drainage canal, which is the point of beginning; thence proceed in a Southeast direction following the middle of the drainage canal to a line that separates the Northwest $\frac{1}{4}$ and the Southwest $\frac{1}{4}$ of the Northwest $\frac{1}{4}$ S14 T9S R14E; thence go down the center of the canal in six courses:

South 34 degrees, 30 minutes, 48 seconds East 118.25 ft.;
South 51 degrees, 56 minutes, 10 seconds East 202.01 ft.;
South 55 degrees, 26 minutes, 55 seconds East 120.21 ft.;
South 42 degrees, 27 minutes, 04 seconds East 69.11 ft.;
South 25 degrees, 12 minutes, 26 seconds East 242.53 ft.;
and South 00 degrees, 11 minutes, 27 seconds West 330.0 feet to a point;

Thence South 89 degrees, 52 minutes East 1488.51 feet to a point; Thence South to the Southeast corner of the Northwest $\frac{1}{4}$ of Section 14 T9S R14E; Thence East to the right-of-way of I-10; Thence go in a Northeasterly direction along right-of-way of I-10 to the section line dividing Section 11 & 14, Thence West along the section line approximately 640 feet until it intersects with the property belonging to a Mrs. Brown; Thence South 1172 feet; Thence West 330 feet; Thence North 39 degrees 45 minutes West 1030.92 feet; Thence West 660 feet; Thence North 312.15 feet to the South right-of-way of Daney Street; Thence West along the South right-of-way of Daney Street to the point of beginning. Containing 165 acres, more or less.

SECTION 2. All of the property described above shall be included in, and become part of, the City of Slidell, Louisiana.

This Ordinance having been submitted to a vote, the vote thereon was as follows:
