

ORDINANCE NO. 1063

An Ordinance of the City of Slidell, Louisiana, enlarging the boundaries of the said City.

WHEREAS, the City Council of the City of Slidell, Louisiana, the governing Body of said municipality, did receive a petition from Alice Grace Canulette Cusimano, Eugenia Canulette Richmond, Lois Canulette, Frank K. Canulette, Ernest L. Canulette, Andrew Mayo Canulette, requesting the enlargement of the City's boundaries and

WHEREAS, the said governing Body did investigate and did find that said petitioner is the sole owner of said property and did give notice of its intention to extend the corporate limits as requested in said petition, by publication in the Slidell Daily Sentry News, March 30th, 1978, and a public hearing was held April 11th, 1978 on said petition,

NOW THEREFORE BE IT ORDAINED by the City Council of the City of Slidell, Louisiana, in legal session convened:

SECTION 1. The boundaries of the City of Slidell, Louisiana, be enlarged to include the following described property, to-wit:

Parcel 1

All that certain parcel of land being situated in Section 1, Township 9 South, Range 14 East, St. Tammany Parish, Louisiana, being more fully described as follows:

From the Section corner common to Sections 2, 1, 11, and 12 in said Township and Range, go North 00 degrees, 53 minutes, 36 seconds West 620.44 feet to the point of beginning. Thence from the point of beginning continue North 00 degrees, 53 minutes, 36 seconds West 199.56 feet to a point; thence go North 89 degrees, 13 minutes, 10 seconds East 708.24 feet to a point; thence go South 02 degrees, 21 minutes, 41 seconds East 199.64 feet to a point; thence go South 89 degrees, 13 minutes, 10 seconds West 713.36 feet back to the point of beginning. Containing in all 3.2564 acres of land more or less.

Parcel 2

All that certain parcel of land being situated in Section 1, Township 9 South, Range 14 East, St. Tammany Parish, Louisiana, being more fully described as follows:

From the Section corner common to Sections 2, 1, 11, and 12 in said Township and Range, go North 00 degrees, 53 minutes, 36 seconds West 820.00 feet to the point of beginning. Thence from the point of beginning continue North 00 degrees, 53 minutes, 36 seconds West 824.65 feet to a point; thence go North 89 degrees, 13 minutes, 10 seconds East 496.39 feet to a point; thence go South 45 degrees East 281.45 feet to a point; thence go South 02 degrees, 21 minutes, 41 seconds East 623.18 feet to a point; thence go South 89 degrees, 13 minutes, 10 seconds West 708.24 feet back to the point of beginning. Containing in all 12.7663 acres of land, more or less.

Parcel 3

All that certain parcel of land being situated in Section 1, Township 9 South, Range 14 East, St. Tammany Parish, Louisiana, being more fully described as follows:

From the Section corner common to Sections 2, 1, 11, and 12 in said Township and Range, go North 00 degrees, 53 minutes, 36 seconds West 2644.64 feet to a point; thence go North 89 degrees, 02 minutes, 57 seconds East 496.39 feet to the point of beginning. Thence from the point of beginning continue North 89 degrees, 02 minutes, 57 seconds East 1752.07 feet to a point; thence go South 17 degrees, 10 minutes, 07 seconds West along the Westerly Right-of-Way line of Interstate 10 a distance of 1236.17 feet to a point; thence go South 87 degrees, 38 minutes, 17 seconds West 1173.30 feet to a point; thence go North 45 degrees West 281.45 feet to a point; thence go North 00 degrees, 53 minutes, 36 seconds West 1001.48 feet back to the point of beginning. Containing in all 42.1510 acres of land, more or less.

SECTION 2. All of the property described above shall be included in, and become part of, the City of Slidell, Louisiana, and zoned C-4 Commercial.

This Ordinance having been submitted to a vote, the vote thereon was as follows:
