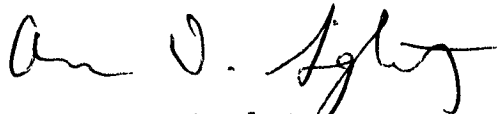

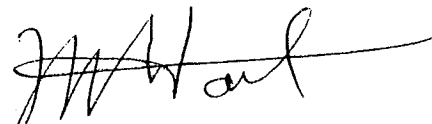

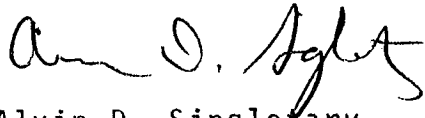

ORDINANCE

NO. 1088

An ordinance adding Section 12.41 of the Code of Ordinances of the City of Slidell by restricting parking on the east side of Seventh Street and on the south side of Fairbanks Street in the vicinity of Possum Hollow Park.

Be it enacted by the City Council of the City of Slidell, Louisiana, in legal session convened, that the Code of Ordinances of the City of Slidell be changed to add:

Section 12.41 No Parking

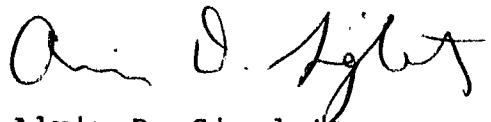
A. No parking shall be allowed on the west side of Seventh Street, from Cousin Street southward to Possum Hollow Park.

B. Parking shall be allowed on the east side of Seventh Street from Cousin Street southward to Possum Hollow Park.

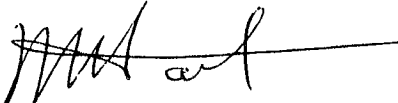
C. No parking shall be allowed on the south side of Fairbanks Street from Sixth Street eastward to the Dead End of Fairbanks Street.

D. Parking shall be allowed on the north side of Fairbanks Street from Sixth Street eastward to the Dead End of Fairbanks Street.

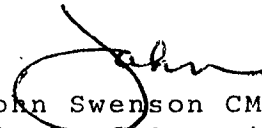
