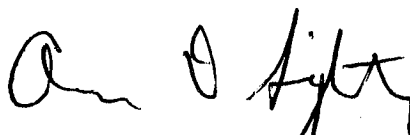

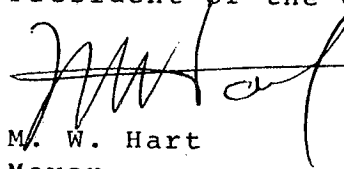

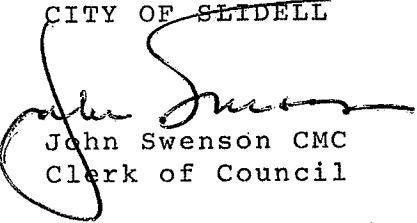
PUBLIC NOTICE
