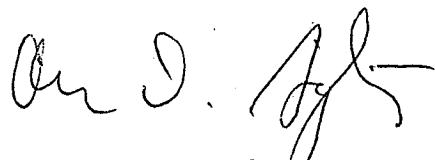

convened, that: Churches shall be exempt from this Ordinance.

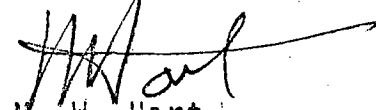
Any person, firm or corporation petitioning to have

is not granted.

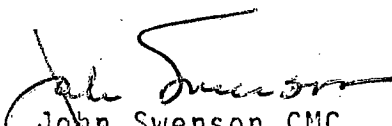
