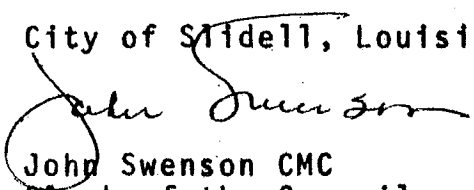

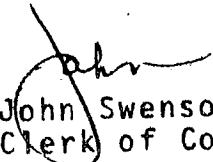

Gentlemen and Mrs. Wood:

I am recommending the following amendments to the budget:

In Finance, add \$1,400.00: \$750.00 for increase in General Fund's share of the audit fees, and \$650.00 for judgment.

Add \$13,107.00 to Sales Tax Administration for Employee Medical in the amount of \$7,700.00 which was understated in the present budget and \$5,407.00 for the Sales Tax share of the audit fees. Also add automobile purchases for the Police Department in the amount of \$57,300.00 in the capital budget. There will be an amendment to the 1980 budget recommended that we add \$13,431.00 from Federal Revenue Sharing to this item making a total of \$70,731.00.

We are deducting from Streets, Bridges and Drainage \$28,650.00, from Special Construction \$34,057.00, and from Engineering \$7,700.00 in order to have the money in order to make these changes. This releases \$57,300.00 in Revenue Sharing which had previously been allocated to finish out the EDA auditorium grant.

In the Utility Fund, amend the Administrative line by \$12,812.00: \$4,412.00 is for the audit allocation for the Utility Fund and \$8,400.00 is for postage. Amend the Treatment Plant budget by adding \$13,418.00 to take care of increased utilities. In Water and Sewer, add \$47,702.00: \$26,000.00 to go to Supplies and Materials because of increased demands on the Front Street project, leaving \$21,702.00 for Maintenance. These items will be funded from the Water Escrow Account.
