is hereby rescinded and declared null and void.

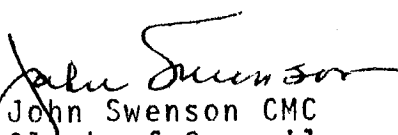

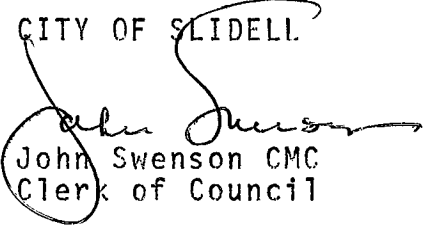
PUBLIC NOTICE
