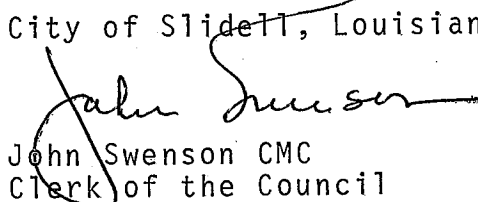
PUBLIC NOTICE

MINUTES

July 23, 1979

Minutes of a special meeting held on the above date at 9:15 A. M. in the Conference Room, City Hall, Slidell, Louisiana. This meeting was held in the compliance with the Sunshine Law.

The Chairman called the meeting to order.

The first item on the agenda, review of 1980 budget, was tabled at the request of the Chairman pending consideration by the entire Board.

The second item on the agenda was disposition of personnel files. The Director referred to a letter from Mayor Hart dated July 2, 1979 wherein he requested that certain personnel records be transferred to the newly established Personnel Department. After discussion with the Mayor, it was decided that the original application, the physical report from examining physician, testing information and all pay records will be retained by Civil Service.

The next item on the agenda was a request from Nell Parker and Charlene Williams to amend the pay plan to recognize in some manner, long time employees who have reached the maximum authorized. The Chairman pointed out that action was being taken to review this category of employee and a meeting will be called for Monday, July 30, 1979 to examine the alternatives.
