Minutes of a special meeting of the Mayor and Board of Aldermen of the Town of Slidell, Louisiana, called by the Mayor pursuant to the attached notice and the return on the back thereof, held at the Town Hall, Slidell, Louisiana, February 25, 1952, at 7:30 P. M.

WHEREAS the Police Jury of St. Tammany Parish by resolution adopted on January 17, 1952, has created a fire protection district in parts of the 8th and 9th wards of said parish and fixed the boundaries of said district; and

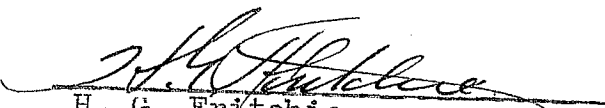
WHEREAS the Police Jury of St. Tammany Parish by resolution adopted on February 7, 1952, has confirmed the creation of said district and has provided that said district so created shall be known as "Fire Protection District No. One, St. Tammany Parish, Louisiana"; and

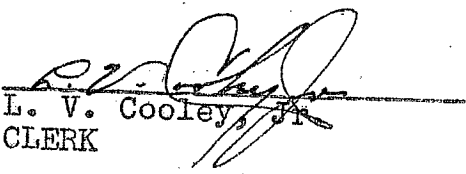
WHEREAS the Town of Slidell, is included within the boundaries of said Fire Protection District as so created; and

WHEREAS the Town of Slidell desires to be included within the boundaries of said district and to concur in the fixing of the boundaries of said district;
