

ORDINANCE NO. 499 C

An Ordinance of the Town of Slidell, Louisiana, to amend and reenact Section One of Ordinance No. 499 A of said Town which is an ordinance to regulate the vehicular traffic in the Town of Slidell, Louisiana.

SECTION 1: Be it ordained by the Mayor and Board of Aldermen of the Town of Slidell, Louisiana in legal session convened that Section One of Ordinance No. 499 A of the Town of Slidell which is an ordinance to regulate the vehicular traffic in the Town of Slidell, Louisiana, be and the same is hereby amended and reenacted to read as follows:

"SECTION 1: Be it ordained by the Mayor and Board of Aldermen of the Town of Slidell, Louisiana in legal session convened that it be unlawful for any person or persons to drive, or operate, a vehicle of any kind or description through the streets, roads, or highways of the Town of Slidell at a greater rate of speed than 25 miles per hour, except on the following streets, roads or highways of the Town of Slidell, Louisiana:

a. On U. S. Highway No. 11 from a point 1000 feet from the South boundary line of the Town of Slidell to Rosa Street, the speed shall not exceed 45 miles per hour; and from Rosa Street to Junction of U. S. Highway No. 11 with U. S. Highway No. 190 West, the speed shall not exceed 30 miles per hour; and from said Junction to the North boundary of the Town of Slidell, the speed shall not exceed 45 miles per hour.

b. On State Highway No. 433 or Rigolet Drive from South boundary of the Town of Slidell to Slidell Avenue, speed shall not exceed 45 miles per hour; from Slidell Avenue to Junction of Highway U. S. No. 11, speed shall not exceed 35 miles per hour.

c. On Bayou Liberty Road or State Highway 433 from the Southern Railway to the West boundary of the Town of Slidell, speed shall not exceed 35 miles per hour.

d. On U. S. Highway No. 190 West, or the Baton Rouge-Slidell Highway, from Carnation Street to the West boundary line of the Town of Slidell, the speed shall not exceed 45 miles per hour.

e. On East Hall Avenue or State Highway No. 1091, from U. S. Highway No. 11 to East boundary of the Town of Slidell, speed shall not exceed 30 miles per hour.

f. On Fremaux Avenue or U. S. Highway No. 190 East, from the East boundary of the Town of Slidell to Sixth Street, speed shall not exceed 45 miles per hour; and from Sixth Street to U. S. Highway No. 11, speed shall not exceed 30 miles per hour.

When turning any corner or within a radius of 200 feet of the entrance to any school building, the rate of speed shall not exceed 10 miles per hour.

South bound traffic on U. S. Highway No. 11 or Front Street shall not turn left on to First Street.

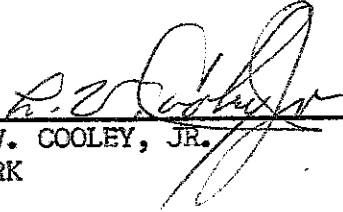
North bound traffic may turn right into U. S. Highway 190 East or Fremaux Avenue on either red or green light."

SECTION 2: Be it further ordained that all ordinances or parts of ordinances in conflict herewith and especially the original Section One of Ordinance No. 499 A be and the same is hereby repealed.

SECTION 3: Be it further ordained that this ordinance shall go into effect immediately after its passage and promulgation.
