

ORDINANCE NO. 621

An ordinance of the Town of Slidell, Louisiana levying an annual license tax upon all persons, corporations or associations or persons pursuing any trade, calling, occupation or profession not exempt by law within the corporate limits of the Town of Slidell, Louisiana, except insurers.

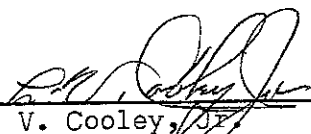
SECTION 1. Be it ordained by the Mayor and Board of Aldermen of the Town of Slidell, Louisiana, in legal session convened that a license tax is hereby levied for the year 1960 upon all persons, corporations or associations of persons pursuing any trade, calling, business, profession or occupation within the corporate limits of the Town of Slidell, Louisiana, except insurers as provided by Ordinance No. 548 as amended by Ordinance No. 558 of the Town of Slidell, Louisiana.

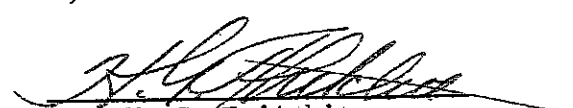
SECTION 2. Be it further ordained that the amount of said license tax shall be the same as that levied by the State of Louisiana for said business, profession, trade, occupation or calling as fixed by the Constitution and laws of the State of Louisiana.

SECTION 3. Be it further ordained that it shall be the duty of the tax collector to notify all license tax payers when the said tax is due by them and when the same shall become delinquent and he shall report all delinquents to the Town Attorney who is hereby empowered to institute suit for the collection of the same in accordance with the Constitution and Laws of the State of Louisiana.

SECTION 4. Be it further ordained that this ordinance shall go into effect immediately after its passage and promulgation.

ORDINANCE NO. 622

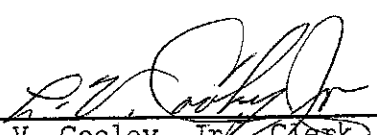
An Ordinance of the Town of Slidell, Louisiana, levying a special tax of four mills on the dollar on all taxable property in the Town of Slidell, Louisiana, for the purpose of garbage disposal and maintenance thereof in the Town of Slidell, Louisiana.

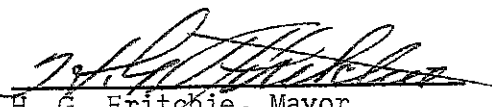
SECTION 1. Be it ordained by the Mayor and Board of Aldermen of the Town of Slidell, Louisiana, in legal session convened, that there is hereby levied a tax of four mills on the dollar upon all property taxable under the Laws of the State of Louisiana, situated in said Town, according to the assessment roll of said Town for the year 1959.

SECTION 2. Be it further ordained that said tax is levied for the purpose of garbage disposal and maintenance thereof in the Town of Slidell, Louisiana, for the year 1960, all as authorized by the Special Tax Payer election held in the Town of Slidell, Louisiana, July 23, 1957.

SECTION 3. Be it further ordained that this ordinance shall go into effect immediately after its passage and promulgation.
