

ORDINANCE NO. 634

An ordinance of the Town of Slidell, Louisiana, levying a special tax of four and twenty-five one-hundredths (4.25) mills on the dollar on all taxable property in the Town of Slidell, Louisiana, sufficient to pay maturing bonds and interest of the Sewerage Public Improvement Bonds of the Town of Slidell, Louisiana, for the year 1961.

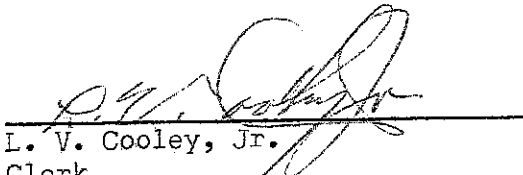
SECTION 1. Be it ordained by the Mayor and Board of Aldermen of the Town of Slidell, Louisiana, in legal session convened, that there is hereby levied a special tax of 4.25 mills on the dollar on all taxable property under the laws of the State of Louisiana, situated in the Town of Slidell according to the assessment roll of the said Town for the year 1960.

SECTION 2. Be it further ordained that the said special tax is levied for the purpose of providing an amount sufficient to pay interest and maturing bonds of the Sewerage Public Improvement Bonds of the Town of Slidell, Louisiana, for the year, 1961, as duly authorized by a resolution of the Mayor and Board of Aldermen of the Town of Slidell, Louisiana, passed on the 28th day of April, 1958.

SECTION 3. Be it further ordained that this ordinance shall go into effect immediately after its passage and promulgation.

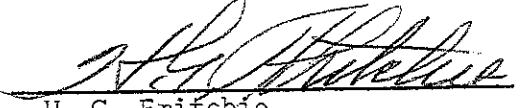

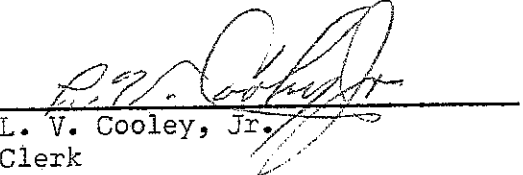
SECTION 1. Be it ordained by the Mayor and Board of Aldermen of the Town of Slidell, Louisiana, the governing authority of Sewerage District Number 1-A of the Town of Slidell, Louisiana, in legal session convened, that there is hereby levied a special tax of 4.25 mills on the dollar on all taxable property under the laws of the State of Louisiana, situated in the Town of Slidell according to the assessment roll of the said Town for the year 1960.

SECTION 2. Be it further ordained that the said special tax is levied for the purpose of providing an amount sufficient to pay interest and maturing bonds of the Sewerage Public Improvement Bonds of Sewerage District Number 1-A of the Town of Slidell, Louisiana, for the year 1961, as duly authorized by a resolution of the Mayor and Board of Aldermen of the Town of Slidell, Louisiana, passed on the 28th day of April, 1958.

SECTION 3. Be it further ordained that this ordinance shall go into effect immediately after its passage and promulgation.
