

ORDINANCE NO. 659

AN ORDINANCE OF THE CITY OF SLIDELL, LOUISIANA, ENLARGING THE BOUNDARIES OF SAID CITY TO INCLUDE A PORTION OF THE PROPOSED POLLARD ESTATES SUBDIVISION AND A PORTION OF THE ROBERT ROAD.

WHEREAS the Mayor and Board of Aldermen of the City of Slidell, the governing body of said municipality, did receive at their regular meeting of Tuesday, June 5, 1962, a petition from O. Miles Pollard, Jr. to extend the corporate limits of the City of Slidell to include a portion of certain property known as Pollard Estates Subdivision and a portion of the Robert Road and;

WHEREAS said governing body did investigate and did find that said O. Miles Pollard, Jr. is the sole owner of the said portion of said proposed Pollard Estates subdivision and did give notice of a hearing on said petition to be held on the 18th day of June, 1962 at the City Hall at 7:30 P.M. by publication in the Slidell St. Tammany Times and Weekly News under date of June 7, 1962. That said hearing was held on said date. There were approximately fifty persons present. Of those present two appeared in opposition to said petition.

Section 1. THEREFORE BE IT ORDAINED by the Mayor and Board of Aldermen of the City of Slidell, Louisiana, in legal session convened that the boundaries of the City of Slidell, Louisiana be enlarged to include the following described property to-wit:

(1st) All of the following described lands, lying east of Southern Railroad, south of proposed Interstate Highway # 12 and west of Interstate Highway # 10:

The S $\frac{1}{2}$ of NW $\frac{1}{4}$ Section 35
The S $\frac{1}{2}$ of NE $\frac{1}{4}$ Section 35
The N $\frac{1}{2}$ of SE $\frac{1}{4}$ Section 35
The S $\frac{1}{2}$ of NW $\frac{1}{4}$ Section 36
The N $\frac{1}{2}$ of SW $\frac{1}{4}$ Section 36
The SE $\frac{1}{4}$ of SW $\frac{1}{4}$ Section 36
The SW $\frac{1}{4}$ of NE $\frac{1}{4}$ Section 36
The W $\frac{1}{2}$ of SE $\frac{1}{4}$ Section 36

All in T 8 S R 14 E 8th Ward, St. Tammany Parish, Louisiana.

(2nd) The right of way of State Highway #1091 (known as the Robert Road) being 30 feet either side of the present center line and extending in a southwesterly direction from the south line of the above described N $\frac{1}{2}$ of SW $\frac{1}{4}$ Section 36 a distance of approximately 10,500 feet to the present corporate limit of the City of Slidell.

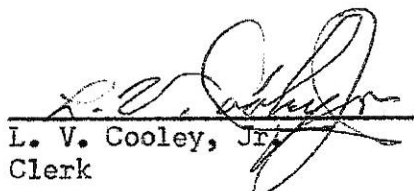

Section 2. BE IT FURTHER ORDAINED that all of the property as above described shall be included in and become a part of the said City of Slidell, Louisiana.

Section 3. BE IT FURTHER ORDAINED that this ordinance shall become operative thirty days after its publication.
