

Ordinance 680-1

An ordinance of the City of Slidell, Louisiana, enlarging the boundaries of the said City to include the following described land.

WHEREAS the Mayor and Board of Aldermen of the City of Slidell, Louisiana, the governing body of said municipality, did receive at the regular meeting of February 28th, 1963, a petition from George E. Reine, Jr. and the Spilka Estates, by George E. Reine Jr., Agent, owners of the property herein described;

WHEREAS said governing body did investigate and did find that said petitioners are the sole owners of said property and did give notice of a hearing on said petition to be held on March 17th, 1963, at the City Hall by publication in the Slidell St. Tammany Times under date of March 7th, 1963. That said hearing was held on said date and at said hearing no one appeared in opposition to said petition.

SECTION ONE: THEREFORE BE IT ORDAINED by the Mayor and Board of Aldermen of the City of Slidell, Louisiana, in legal session convened that the boundaries of the City of Slidell, Louisiana, be enlarged to include the following described property to-wit:

All that part of the NE $\frac{1}{4}$ of Section 2, T9SR 14E, St. Tammany Parish, Louisiana, lying East and South of Robert Road except that portion described as follows: Beginning at the East $\frac{1}{4}$ corner of Section 2 T 9 SR 14 E, St. Tammany Parish, Louisiana, go north 89° 46' West 660.18 feet to a point, thence north 1,319.7 feet to a point; thence south 89° 46' east 660.18 feet to a point thence south along the Section line a distance of 1,319.6 feet to the point of beginning;

And all that part of the North half of the south half of section 2 T9 SR 14E, St. Tammany Parish, Louisiana, lying east of the Robert Road.

SECTION TWO: THEREFORE BE IT ORDAINED that all of the property as above described shall be included in and become a part of the said City of Slidell, Louisiana.

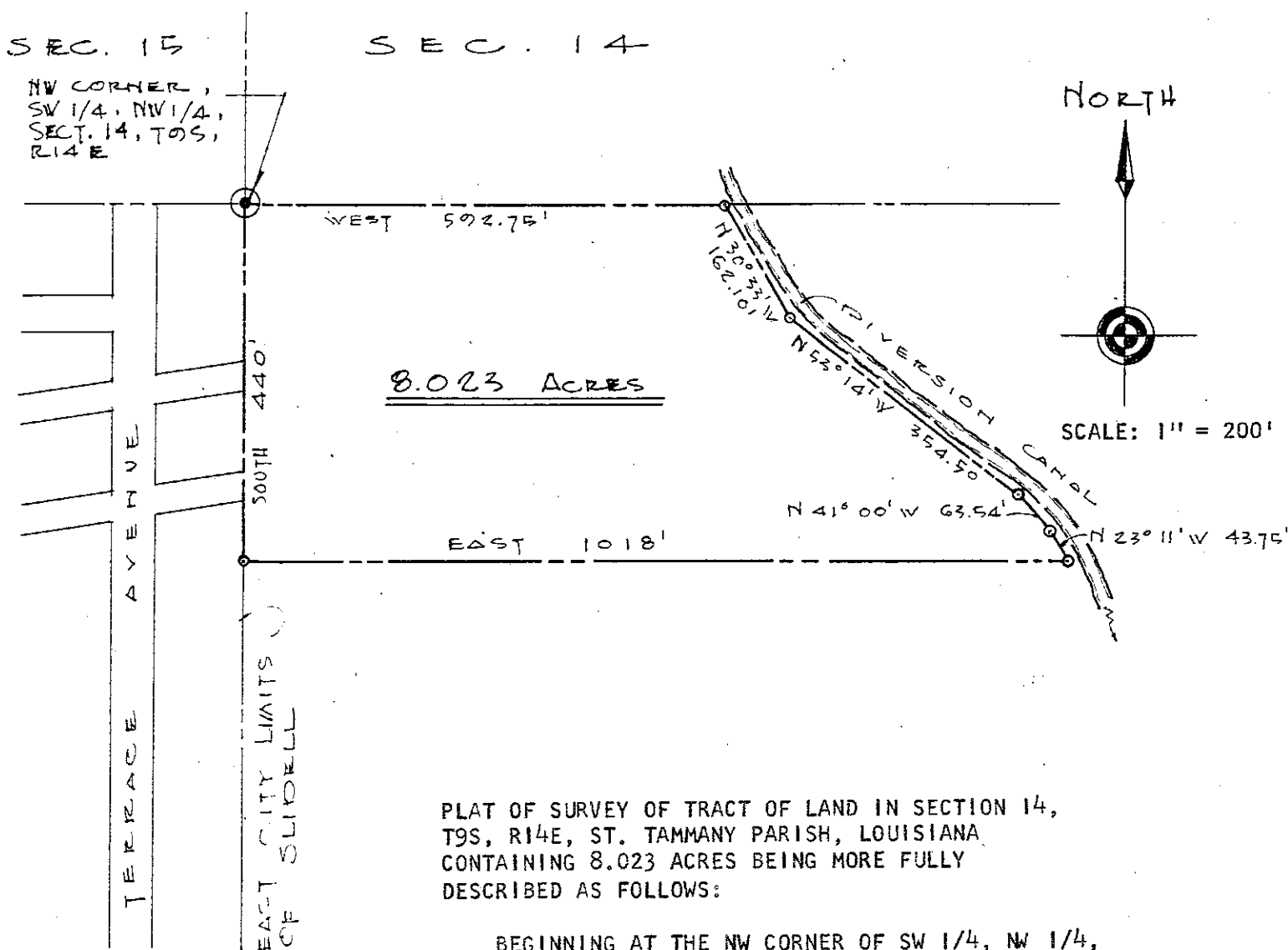
