

ORDINANCE #683

Declaring that information has come to the City of Slidell that certain property in and adjoining the city limits of the City of Slidell was subdivided into Brugier Subdivision Second addition but that said plat is not of record, and said streets indicated on said plat were never dedicated as public streets, accepted as public streets, or maintained as public streets, and that, if, for any reason, there has been any dedication of these areas as streets, that this dedication is revoked and set aside.

WHEREAS, a map is purported to have been drawn showing certain streets in Brugier Subdivision Second Addition of which EAST RIDGE PARK Subdivision in the City of Slidell now forms a part, and,

WHEREAS, the owners of the property in the chain through which these areas are shown has never dedicated these areas as streets; and

WHEREAS, the City of Slidell has never accepted any dedication of these areas as streets, and any attempt to dedicate them would violate the municipal ordinances relative to the dedication of streets; and,

WHEREAS, none of these streets have ever been improved in any way or maintained in any way, either by the City of Slidell, or by any other public body, or by any private owner; and,

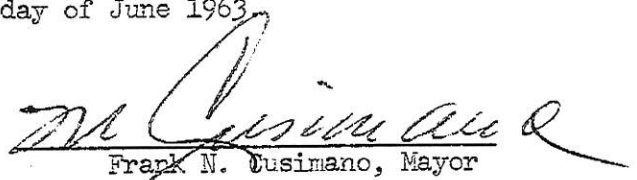
WHEREAS, even if there had been some dedication of these areas, these areas are not needed as streets, and serve no function as streets, and,

WHEREAS, the owner of this property has requested that an ordinance declaring the facts set forth above be adopted, and that the dedication, if any has been made, be revoked and set aside;

NOW THEREFORE, BE IT ORDAINED by the Board of Aldermen of the City of Slidell that the area referred to above, designated on the map as East Ridge Park Subdivision which has been incorporated in the City limits of the City of Slidell by action by the Mayor and Board of Aldermen on December 4, 1962 and that there has been no dedication of any streets in this property other than as shown on the plat of East Ridge Park Subdi-

vision, and that, therefore, any dedication of any streets by virtue of the plat of said Brugier Subdivision Second Addition, or by virtue of any other plat of act of dedication being and it is hereby revoked insofar as it applies to the East Ridge Park Subdivision and no further.

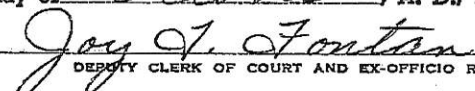
