Request is hereby made by the undersigned property owners, being all of the property owners of the below described property, to bring this property into the corporate limits.

DESCRIPTION OF PROPERTY:

Starting at the present city limits located at the Northwest corner of Hermadel Estates Subdivision on West Hall Avenue, run along the southerly right of way line of West Hall Avenue to its intersection of the westerly right of way line of Carroll Road, a distance of 850' more or less; thence run along the westerly right of way line of Carroll Road a distance of 225' more or less to the southeasterly corner of Lot 23, Square J., Bayou Liberty Gradients Subdivision; thence run in a westerly direction along the southerly property lines of Lots 23, 16, 15, 14, 13, 12, 11, 10, 9, 8, 7, 6, 5, 4, 3, 2, and 1 a distance of 2005.46' to the southwesterly corner of Lot 1, Square J., Bayou Liberty Garden Subdivision, being on the East side of East Avenue; thence run along the westerly line of said Lot 1, a distance of 284.16' to the northwest corner of said Lot 1 being the Southeast corner of Liberty Drive and East Avenue; thence run easterly along the south right of way line of Liberty Drive a distance of 2,264' more or less, to its intersection with the easterly line of said Carroll Road; thence run in a Southwesterly direction a distance of 700' more or less to the Northeast corner of said Carroll Road and said West Hall Avenue; thence run in an easterly direction along the north right of way line of said West Hall Avenue to the present city limits at the Southwest corner of Carolyn Park Subdivision.
