

MINUTES
SPECIAL CITY COUNCIL MEETING
SEPTEMBER 1, 1983
6:30 P.M.

1 The meeting was called to order by the President of the Council, Philip
2 M. Salvaggio. All Council Members and Mayor Hart were present with the exception
3 of Councilman At Large Martinez.

5 Mayor Hart stated that sealed bids were opened on August 30th, 1983
6 at 10:00 A.M. in the presence of Steve Buser, Billie Spiers and Jack Boyd
7 for Replacement blowers and Electrical Motor. The following bid was received.

9 Gregory-Salisbury & Co., Inc. \$28,765.00

11 Councilman At Large Singletary, seconded by Councilman Van Sandt moved
12 that based on the recommendation of the Administration the bid in the amount
13 of \$28,765.00 from Gregory - Salisbury & Co., Inc. be accepted.

15 After further discussion, the above motion was withdrawn and substituted
16 with the following motion.

18 Councilman At Large Singletary, seconded by Councilman Van Sandt moved
19 that based on the recommendation of the Administration and the City Attorney the
20 bid in the amount of \$28,765.00 from Gregory - Salisbury & Co., Inc. be accepted.

25 Mayor Hart stated that written quotes were received for backhoe attachments.

27 Councilman At Large Singletary, seconded by Councilman Barthelemy moved
28 that based on the recommendation of the administration the quote in the amount of
29 \$4,929.00 from Furlow-Laughlin Equipment Inc. be accepted.

31 After further discussion, the above motion was withdrawn and substituted
32 with the following motion.

34 Councilman At Large Singletary, seconded by Councilman Barthelemy moved
35 that based on the recommendation of the Administration and the City Attorney the
36 quote in the amount of \$4,929.00 from Furlow-Laughlin Equipment Inc. be accepted.

38 Councilman Callahan read the following section and requested it be made
39 a part of these minutes.

41 "Purchases of \$3,000 or more but less than \$5,000, and this is \$4,929.00,
42 shall be made by sending out written invitation for bid to at least five (5)
43 bona fide qualified bidders. Did we do that?"

45 Mayor Hart: "Jack said he sent three."
46

47 Councilman Callahan: "Then it is in violation of state bid law and
48 I still stand by my statement."

50 Mayor Hart requested withdrawal for the quote for backhoe attachments.

52 Mayor Hart announced that sealed bids were opened on August 25th, 1983
53 in the presence of Steve Buser, Billie Spiers, Virginia Roe and Jack Boyd for
54 one (1) Winch. The following bids were received:

58 Dealers Truck Equipment Company \$4,949.38

60 Councilman Van Sandt, seconded by Councilman Singletary moved that based
61 on the recommendation of the Administration the bid be accepted from Dealers Truck
62 Equipment Company in the amount of \$4,949.38 for one (1) winch.

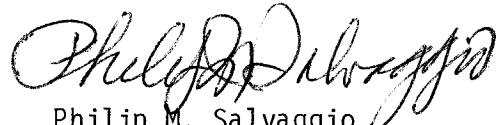
67 Councilman Van Sandt, seconded by Councilman At Large Singletary moved that
68 based on the recommendation of the Administration and the City Attorney the bid be

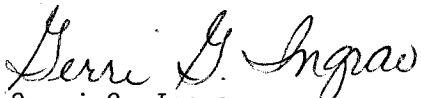
