

ORDINANCE NO. 835

The following ordinance was offered by Mr. Hinton and
seconded by Mr. Smith:

LOCAL OR SPECIAL ASSESSMENT ORDINANCE NO. 3 OF
1964 SEWERAGE DISTRICT NO. 1-A OF THE CITY OF
SLIDELL, LOUISIANA.

An ordinance amending Local or Special Assessment Ordinance No. 1 of 1964, Sewerage District No. 1-A of the City of Slidell, Louisiana, adopted by the Mayor and Board of Aldermen of the City of Slidell, Louisiana, on December 15, 1964, entitled:

"An ordinance providing for the levying of a local or special assessment on each lot or parcel of real estate abutting the streets as set out in the notice of intention adopted on November 19, 1963, as amended, within the area of Sewerage District No. 1-A of the City of Slidell, Louisiana in proportion that the frontage of each lot bears to all of the abutting lots or parcels of real estate to be improved by the construction of sewerage collection facilities, all in accordance with the provisions of Title 33, Part 11, Sub-Part A, Chapter 9, Louisiana Revised Statutes of 1950, as amended."

BE IT ORDAINED by the Mayor and City Council of the City of Slidell, Louisiana, acting as the governing authority of Sewerage District No. 1-A of said City:

SECTION 1. That Section 1 of Local or Special Assessment Ordinance No. 1 of 1964, Sewerage District No. 1-A of the City of Slidell, Louisiana, adopted by the Mayor and Board of Aldermen of the City of Slidell, Louisiana on December 15, 1964, and recorded in MOB 240 folio 459, be and the same is hereby, amended by correcting the following assessments to read as follows:

SECTION 2. That said Local and Special Assessment Ordinance No. 1-A of 1964, Sewerage District No. 1-A of the City of Slidell, Louisiana be further amended by eliminating therefrom Assessment No. 515.

SECTION 3. That the Clerk of Court and Ex-Officio Recorder of Mortgages in and for the Parish of St. Tammany, Louisiana, be and he is hereby, empowered, authorized and directed to correct Assessments No. 224, 231 and 596, recorded in MOB 240, folio 459, to read as hereinabove set forth, and to cancel from his records any lien in contravention to this amendment.

SECTION 4. That this ordinance shall be published in the official journal of the City of Slidell, Louisiana, and shall be in full force and effect immediately upon its adoption, being an ordinance for the immediate preservation of public peace, health and safety.

SECTION 5. That all ordinances or parts of ordinances in conflict herewith be, and the same are hereby, repealed.

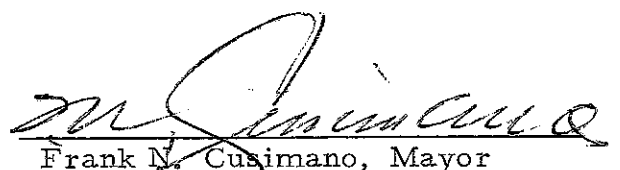
This ordinance having been submitted to a vote, the vote thereon was as follows:
