

An Ordinance Revoking the Dedication of a portion of Peach Tree Street, Poplar Street, and De Soto Street, and vacating and setting aside the dedication thereof.

BE IT ENACTED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SLIDELL, LOUISIANA, IN LEGAL SESSION CONVENED:

1. That it has been established and this body has determined that the portion of streets described hereinafter are not needed or used for the public purposes and that the revocation of the dedication and setting aside thereof will not interfere with the public, and further that the property owners abutting on said portion of streets have requested and approved of the revocation of the dedication and the setting aside thereof.

A. A portion of Peach Tree Street being more fully described as follows, to-wit:

ALL THAT CERTAIN LOT OR PARCEL OF LAND lying and being situated in Windsor Place Subdivision, City of Slidell, Section 44, Township 9 South, Range 14 East, St. Tammany Parish, Louisiana, more fully described as follows:

Commencing at the Southeast corner of Lot 12, common to the westerly boundary of Peach Tree Street, also the point of beginning, go in a northwesterly direction along Lot 12 a distance of 15.0 feet; thence go East, a distance of 52.72 feet to a point along Lot 13; thence go in a southeasterly direction along Lot 13 a distance of 15.0 feet; thence go West, a distance of 52.72 feet back to the point of beginning.

B. A portion of Poplar Drive being more fully described as follows, to-wit:

ALL THAT CERTAIN LOT OR PARCEL OF LAND lying and being situated in Windsor Place Subdivision, City of Slidell, Section 44, Township 9 South, Range 14 East, St. Tammany Parish, Louisiana, more fully described as follows:

Commencing at the Northeast corner of Lot 20, common to the South boundary of Poplar Drive, go North, a distance of 50.03 feet to the Southeast corner of Lot 21; thence go along the North boundary of said street West, a distance of 50.03 feet; thence go East along the South boundary of said street a distance of 15.0 feet back to the point of beginning.

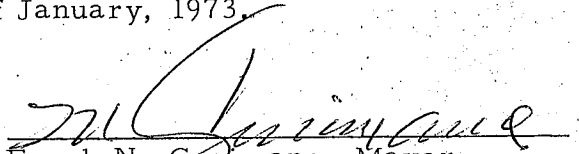
C. A portion of De Soto Street being more fully described as follows, to-wit:

ALL THAT CERTAIN LOT OR PARCEL OF LAND lying and being situated in Section 44, Township 9 South, Range 14 East, City of Slidell, St. Tammany Parish, Louisiana, more fully described as follows:

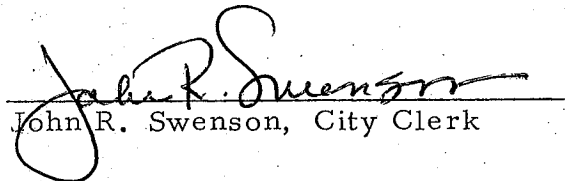
Commencing at the Northeast corner of Lot 43, common to the northern corner of Lot 42, Windsor Place Subdivision, and the South boundary of De Soto Street, also the point of beginning, go North, a distance of 60.0 feet to the North boundary of De Soto Street; thence go along the North boundary of said street West, a distance of 15.0 feet; thence go South, a distance of 60.0 feet; thence go East, a distance of 15.0 feet back to the point of beginning.

2. That the hereinabove described portions of streets shall revert to the adjacent property owners according to law.
