

ORDINANCE NO. 999

AN ORDINANCE REVOKING DEDICATION OF STREETS OF PREVOST ADDITION AND PINE PARK PLACE.

BE IT ENACTED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SLIDELL, LOUISIANA, IN LEGAL SESSION CONVENED:

THAT THE CITY OF SLIDELL APPROVED A SUBDIVISION KNOWN AS PREVOST ADDITION OF THE TOWN OF SLIDELL, LOUISIANA, AND

THAT THE CITY OF SLIDELL APPROVED A SUBDIVISION KNOWN AS PINE PARK PLACE, BEING A RESUBDIVISION OF PREVOST ADDITION, AND

THAT THE CITY OF SLIDELL APPROVED A SUBDIVISION KNOWN AS PARK PLACE A PARTIAL RESUBDIVISION OF PINE PARK PLACE, AND

THAT A QUESTION HAS ARISEN CONCERNING THE REVOCATION OF THE DEDICATION OF THOSE STREETS IN PREVOST ADDITION WHEN THE CITY APPROVED THE PLAT OF PINE PARK PLACE, AND

THAT A QUESTION HAS ARISEN CONCERNING THE REVOCATION OF THE DEDICATION OF THOSE STREETS IN PINE PARK PLACE WHEN THE CITY APPROVED THE PLAT OF PARK PLACE, AND

THAT THE CITY OF SLIDELL WISHES TO AFFIRM THAT THE DEDICATION OF SAID STREETS HAS BEEN REVOKED, NOW THEREFORE

BE IT ORDAINED, THAT THE CITY OF SLIDELL HEREBY EXPRESSLY REVOKES THE PREVIOUS DEDICATION OF THOSE PORTIONS OF STREETS OF PREVOST ADDITION RESUBDIVIDED INTO PINE PARK PLACE, ALL AS SHOWN AND OUTLINED IN RED ON EXHIBIT A ANNEXED HERETO AND MADE A PART HEREOF;

BE IT FURTHER ORDAINED, THAT THE CITY OF SLIDELL HEREBY EXPRESSLY REVOKES THIS PREVIOUS DEDICATION OF THOSE PORTIONS OF STREETS OF PINE PARK PLACE RESUBDIVIDED INTO PARK PLACE, ALL AS SHOWN AND OUTLINED IN RED ON EXHIBIT B ANNEXED HERETO AND MADE A PART HEREOF.

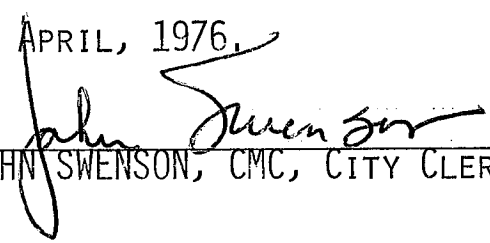
THIS ORDINANCE HAVING BEEN SUBMITTED TO A VOTE, THE VOTE THEREON WAS AS FOLLOWS:

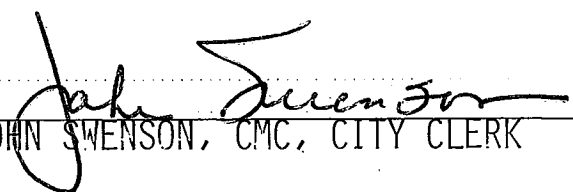
