2. **Minutes.** Motion by Vice Chair Granier to approve minutes of May 4, 2023 as written; Commissioner Provenzano seconded. A vote of 4 YAYS, 0 NAYS, 0 ABSTAIN approved the minutes.

3. **Request for Recommendation**

- a. **T23-04:** A request to amend the City of Slidell Code of Ordinances to support implementation of the *Slidell 2040* Comprehensive Plan amending several sections of the code related to nuisance regulations and due processes.

Introduced by Director McElmurray. Director McElmurray and Evelyn Campo of Desire Line discussed the Comprehensive Plan and gave a run-down of the sections-Sign Code, Multi-Family, Flood Ordinance, Tree and Landscape Ordinance, and Fees. Director McElmurray and Ms. Campo also answered questions by the Board. Vice Chair Granier made a motion to forward to the City Council for approval. Chair West seconded.
