ORDINANCE NO. 1334

BUILDING CODE ADOPTED

An ordinance repealing and replacing Section 7-1 of the Slidell Code of Ordinances, amending Section 7-1.1 of the Slidell Code of Ordinances, repealing Section 7-2 of the Slidell Code of Ordinances, and regulating the erection, construction, enlargement, alteration, repair, moving, removal, conversion, demolition, occupancy, equipment, use, height, area and maintenance of buildings or structures in the City of Slidell; providing for the issuance of permits and collection of fees therefore; declaring and establishing a Fire District; providing penalties for the violation thereof, and repealing all ordinances and parts of ordinances in conflict therewith.

BE IT ORDAINED by the Slidell City Council, in legal session convened, that Section 7-1. Building Code Adopted, of the Slidell Code of Ordinances, is hereby repealed and replaced with the following: Section 7-1. Building Code

Adopted. The Standard Building Code, published by the Southern Building Code

Congress International, Inc., 1976 Edition, along with Appendices A, B, C, D, E, F, G, H, I, L and M, is hereby adopted as the Building Code for the City of Slidell.

BE IT FURTHER ORDAINED that Section 7-1.1. Amendments to Building Code, of the Slidell Code of Ordinances, is amended as follows: Delete the following: "Section 812.5 of the National Building Code adopted by the City of Slidell is hereby amended and reenacted to read as follows: 812.5", and insert in its place the following: Section 902.6 is hereby added to the Standard Building Code adopted by the City of Slidell to read as follows: 902.6

Section 7-1.1. Amendments to the Building Code, after Paragraph G, delete the following: "Section 813 of the National Building Code adopted by the City of Slidell is hereby enacted and added to Article 8 of the National Building Code to read as follows: Section 813." and insert in its place the following: Section 902.7 is hereby added to the Standard Building Code to read as follows: Section 902.7.

This ordinance shall become effective on April 1st, 1981.
