ORDINANCE NO. 1387

An ordinance amending Budget Appropriations Ordinance No. 1259 to:

1. Amend the Police Department Capital Equipment Budget for enough funds to hire 5 new policemen for two months.
2. Amend the Police Department Operating Budget for sufficient funds to cover total projected insurance costs.
3. Amend the Police Department Capital Equipment Budget for enough funds to buy 2 new police cars.
4. Amend the Finance Department Operating Budget for additional office supplies and postage.
5. Amend the Vehicle Maintenance Department Operating Budget for additional unemployment payments, insurance costs, and overtime.
6. Amend Legislative Department Operating Budget for additional retainers for hearing and advertising.
7. Amend Streets, Bridges, Drainage Operating Budget for overtime requirements and insurance costs.
8. Amend Parks and Parkway Maintenance Department Operating Budget for insurance.

BE IT ORDAINED by the Slidell City Council, in legal session convened, that Ordinance No. 1259, an ordinance appropriating funds to implement the Operating Budget and Capital Improvement Program for the Fiscal Year 1980-81, is amended as follows:


