From the section corner common to Sections 15, 16, 21, and 22, in said Township and Range, thence go south 66 degrees, 01 minutes west 321.0 feet to a point; thence go south 26 degrees, 37 minutes west 3005.28 feet to a point; thence go south 63 degrees, 23 minutes east 2120.70 feet to a point; thence north 26 degrees, 37 minutes east 152.28 feet to a point; thence north 89 degrees, 30 minutes east 1796.77 feet to the point of beginning. 
