Beginning at the northeast corner of Lot 1 of Hermadel Estates Sub-division to the City of Slidell, St. Tammany Parish, Louisiana, thence go east along the south right-of-way line of West Hall Avenue, a distance of 89.99 feet to a point; thence go south a distance of 130 feet to a point; thence go west a distance of 90.76 feet to a point, this point being the southeast corner of thence go north along the east property line of said Lot 1 a distance of 130 feet to the point of beginning, all in accordance with a survey by J. S. Boyd & Associates, dated September 24, 1963.


