ORDINANCE NO. 1450

WHEREAS, the Slidell City Council did receive a petition from
the Roman Catholic Church of the Archdiocese of New Orleans, requesting
the annexation and zoning from Parish to A-6 Single Family Urban, and

WHEREAS, the Slidell Planning and Zoning Commission, in a letter
dated October 20, 1981, approved such annexation and zoning, and by pub-
lication in the Daily Sentry News on November 1st, November 8th and November
15th, 1981, the Council gave notice of their intention to take action on
said petition by calling a public hearing on November 24, 1981, in the
Council Chambers,

NOW THEREFORE BE IT ORDAINED by the Slidell City Council, in legal
session convened, that the following described property be annexed into
Councilmanic District E and zoned A-6.

ALL that certain parcel of land being situated in Section 12,
Township 9, South, Range 14 East, St. Tammany Parish, Louisiana,
being more fully described as follows: From the center of Section
12, Township 9 South, Range 14 East go North 89 degrees, 55 minutes,
00 seconds East a distance of 60.00 feet to the Point of Beginning.
From the Point of Beginning go North 00 degrees, 15 minutes, 58
seconds East 298.18 feet along the Easterly Right-of-Way line of a
60-foot right-of-way to a point on the easterly right-of-way line of
Yaupon Drive; thence continue along the said easterly right-of-way
line of Yaupon Drive in two courses: (1) South 85 degrees, 14
minutes, 56 seconds West 13.22 feet to a point; (2) North 00
degrees, 15 minutes, 00 seconds East 714.30 feet to a point on the
southerly right-of-way of Seminole Drive; thence along the said
southerly right-of-way line go South 89 degrees, 59 minutes, 36
seconds east 1,016.38 feet to a point of the westerly right-of-way
of Choctaw Drive; thence along said westerly right-of-way line go
south 00 degrees, 27 minutes, 54 seconds west 16.96 feet to a point;
thence south 89 degrees, 57 minutes, 06 seconds east 277.25 feet to
a point; thence south 00 degrees, 03 minutes, 28 seconds west 992.22
feet to a point; thence south 89 degrees, 55 minutes, 00 seconds west
1,283.78 feet back to the Point of Beginning. Containing in all
29.84 acres of land more or less.
