ORDINANCE NO. 1451

WHEREAS, the Slidell City Council did receive a petition from
the St. Tammany Parish School Board, requesting the annexation and zoning
from Parish to A-6 Single Family Urban, and

WHEREAS, the Slidell Planning and Zoning Commission, in a letter
dated October 20, 1981, approved such annexation and zoning, and by pub-
lication in the Daily Sentry News on November 1st, November 8th and November
15th, 1981, the Council gave notice of their intention to take action on
said petition by calling a public hearing on November 24, 1981, in the
Council Chambers,

NOW THEREFORE BE IT ORDAINED by the Slidell City Council, in legal
session convened, that the following described property be annexed into
Councilmanic District E and zoned A-6.

All that certain parcel of land situated in Section 12, Township 9
South, Range 14 East, St. Tammany Parish, Louisiana, being more fully
described as follows: FROM the corner common to Sections 12, 13, 17,
and 18 in said Township and Range, go south 89 degrees, 37 minutes, 00
seconds West 1006.70 feet to the point of beginning. From the point
of beginning go South 89 degrees, 36 minutes, 57 seconds west along
the northern boundary of Beverly Heights Manor Subdivision 345.09
feet and continue along said bearing for a total of 1690.11 feet to
a point; thence go north 00 degrees, 30 minutes, 45 seconds west
1320.09 feet to a point; thence go north 89 degrees, 30 minutes, 22
seconds east 893.43 feet along the southerly boundary of Holiday
Acres Subdivison to a point; thence go south 39 degrees, 22 minutes,
10 seconds east along the westerly right-of-way line of 100.00 foot
Utility Easement 935.27 feet to a point; thence go south 50 degrees,
37 minutes, 50 seconds west 210.00 feet to a point; thence go south
39 degrees, 22 minutes, 10 seconds east 595.25 feet back to the point
of beginning. The property is generally located north of U.S.
Highway 190 (Shortcut Road) and east of Yaupon Drive.
